**Request of Advisory Neighborhood Commission 8A
For a Moratorium Zone on Martin Luther King, Jr. Avenue, Good
Hope Road, and Minnesota Avenue Corridor, SE
(within ANC 8A Boundaries)
That would prohibit the Sale of Single Containers
Of Alcoholic Beverages in Class A and Class B Establishments**

The Alcoholic Beverage Control Board (Board) announces a public hearing to receive testimony on a written request filed by the Advisory Neighborhood Commission 8A for a Moratorium Zone on Martin Luther King, Jr. Avenue (MLK), Good Hope Road (GHR), and Minnesota Avenue Corridor (MAC), SE (within ANC 8A Boundaries) that would prohibit the sale of single containers of alcoholic beverages in Class A and Class B establishments. ANC 8A's request indicates that it is seeking the Moratorium to promote the goals of: 1) improving the quality of life of ANC 8A residents by reducing the negative impact on the community caused by the sale of singles, such as litter, public drunkenness, and loitering and 2) encouraging and contributing to the economic revitalization of the MLK, GHR, and MAC, SE. The proposed petition also indicates that ANC 8A is seeking to address the issue of crime. The hearing will be held on Wednesday, December 12, 2007 at 9:15 a.m. at 941 North Capitol Street, NE, Board Hearing Room, Washington, D.C. 20002.

Persons wishing to comment may review ANC 8A's written request prior to the public hearing. On June 19, 2007, the Office of Zoning received an application from Jemal's Up Against the Wall, LLC (the "Applicant"). The Applicant requests consolidated review and approval of a planned unit development. The property that is the subject of this application consists of Lots 18, 19, 819, 820 and 821 and a portion of the alley to be closed in Square 347. The property has a total land area of approximately 11,790 square feet and is located in the northwest quadrant of the District. Square 347 is bounded by F Street, N.W., to the north, 10th Street, N.W. to the west, 11 Street, N.W., to the west and E Street, N.W., to the south.

The Applicant proposes to construct a mixed-use development consisting of approximately 91,186 square feet of gross floor area devoted to office use and approximately 6,218 square feet of gross floor area devoted to retail space. The building will be constructed to a maximum height of 120 feet with a total floor area ratio of 8.26. The project will include 68 below grade parking spaces.

The Office of Planning petitioned, on behalf of CHR, LLC, East of the River CDC, and William C. Smith & Co., for text amendments to (1) permit, within the C-1 portion of Square 5912, prepared food shops with more than 18 seats and fast food establishments with no drive-throughs; and (2) exempt, within the C-2-B portion of Square 5912, fast food restaurant with no drive-throughs from the requirements of §§ 721.3(s)(1)-(3).

Square 5912 is split-zoned C-1 and C-2-B. Prepared food shops with 18 or less seats and no drive-throughs are permitted as a matter of right use in the C-1 portion of the site pursuant to 11 DCMR § 701.4(aa). Prepared food shops with more than that number of seats for patrons are subject to the special exception provisions of 11 DCMR § 712.1. No seat limit or drive-through restrictions apply to prepared shops in the C-2-B portion of the site. Fast food establishments are not permitted in the C-1 portion of the site at all, and must comply with certain restrictions to locate in the C-2-B portion.

The Office of Planning's setdown report was filed on October 5, 2007 and the Zoning Commission set down the case for public hearing at its meeting on October 15, 2007. The Office of Planning's setdown report serves as the pre-hearing statement.

Title 11 (DCMR) is proposed to be amended as follows: (New text is shown in **bold and underline**):

Chapter 7, COMMERCIAL DISTRICTS, is amended as follows:

- (a) Section 701.4 (aa) is amended to read as follows:
- (aa) Prepared food shop, with no more than 18 seats for patrons and no drive-through **except that no limitation on seats shall apply to a prepared food shop in Square 5912.**

(b) Section 721, Uses as a Matter of Right (C-2), § 721.3(s) is amended to read as follows:

(s) Fast food establishment or food delivery service, only in a C-2-B or C-2-C District; provided:

- (1) No part of the lot on which the use is located shall be within twenty-five feet (25 ft.) of a Residence District, unless separated therefrom by a street or alley;
- (2) If any lot line of the lot abuts an alley containing a zone district boundary line for a Residence District, a continuous brick wall at least six feet (6ft.) high and twelve inches (12 in.) thick shall be constructed and maintained on the lot along the length of that lot line;
- (3) Any refuse dumpsters shall be housed in a three (3) sided brick enclosure equal in height to the dumpster or six feet (6 ft.) high, whichever is greater. The entrance to the enclosure shall include an opaque gate. The entrance shall not face a Residence District; and
- (4) The use shall not include a drive-through.

Provisions (1), (2), and (3) shall not apply to a fast food establishment located in Square 5912.

Proposed amendments to the Zoning Regulations and Map of the District of Columbia are authorized pursuant to the Zoning Act of June 20, 1938, (52 Stat. 797), as amended, D.C. Official Code § 6-641 *et seq.*
