Reprog. 17-17: Request to reprogram \$1,700,000 of capital budget authority from project MA505C (CDF Roof Replacement) to project CR004C (Renovation and Upgrade of Central Security System) within the Department of Corrections was filed in the Chairman's Office on May 11, 2007. The reprogramming will provide budget authority to ensure sufficient funding for the Central Detention Facility to construct and upgrade the Central Security Command Center, including implementation of Radio Frequency Identification (RFID) system to enhance security.
