The District of Columbia Public Charter School Board invites the public to participate in a public hearing on Howard Road Academy Public Charter School's request to amend its charter.

Howard Road Academy Public Charter School requests to amend its charter in the following area:

- Change from Direct Instruction Math to SRA Real Math

The hearing will be held on Monday, October 16, 2006, in conjunction with the Public Charter School Board's monthly meeting. The presentation and comment on the school's request is scheduled to take place from 7:30-7:55 PM at the DC Public Charter School Board, 3333 14<sup>th</sup> Street, NW in the Conference Room (Columbia Heights Metro – Green Line).

During the October 16<sup>th</sup> public hearing, Howard Road Academy Public Charter School representatives will describe the rationale for the proposed change. The Board invites the public's participation in the hearing and asks members of the public to testify on the impact that the proposed amendment will have on:

1. students, parents, and the community;
2. other public schools in the District of Columbia; and
3. the quality of education in the city.
