Council Chairman Linda W. Cropp announces the rescheduling of a public hearing by the Committee of the Whole on Bill 16-914, the "Closing of a Portion of a Public Alley in Square 85, S.O. 06-8859, Act of 2006." The public hearing, originally scheduled for Thursday, November 9, 2006, at 10:00 a.m., is rescheduled to Wednesday, November 29, 2006, in Room 412 of the John A. Wilson Building, 1350 Pennsylvania Avenue, N.W.

Bill 16-914, introduced by Councilmember Jack Evans, would close a portion of a public alley in Square 85, bounded by K, L, 19th and 20th Streets, N.W., in Ward 2. The applicant, 1925 K Associates LLC whose principal is Charles E. Smith Commercial Realty, is requesting the alley closing to facilitate the redevelopment of a 270,000 square foot office building with ground floor retail, and off-site housing linkage.

Council Chairman Linda W. Cropp announces a public roundtable by the Committee of the Whole on plans for two "new communities" proposed by the Mayor: 1) PR 16-1055, "Barry Farm/Park Chester/Wade Road Redevelopment Plan Approval Resolution of 2006;" and 2) PR 16-1056, "Lincoln Heights/Richardson Dwellings New Communities Initiative Revitalization Plan Approval Resolution of 2006." The roundtable is scheduled for Wednesday, November 29, 2006, at 2:00 pm, in Room 412 of the John A. Wilson Building, 1350 Pennsylvania Avenue NW.

PR 16-1055 would approve a plan to revitalize the Barry Farm/Park Chester/Wade Road neighborhood in Ward 8's historic Anacostia area, and PR 16-1056 would approve a plan to revitalize the Lincoln Heights/Richardson Dwellings neighborhood in the northeastern section of Ward 7. Each plan outlines strategies to: 1) preserve and expand the affordable housing stock; 2) improve the area's economic integration into the larger community; 3) enhance resident opportunities through better job placement, education and training, and overall human services and programs; 4) reduce crime and poverty through targeted actions; 5) establish and reinvest in community services and amenities; and 6) engage residents in decision-making.

Persons presenting testimony may be limited to 3 minutes in order to permit each witness an opportunity to be heard.
