On January 31, 2005 Councilmembers Kathy Patterson, Phil Mendelson and Adrian Fenty, chairs respectively of the Council Committees on Education, Libraries and Recreation; Judiciary; and Human Services will hold a joint public oversight hearing on juvenile homicides in the District of Columbia. The hearing will focus on the doubling of the number of youth homicides in 2004 over 2003; and will provide information on the efforts underway by the Truancy Task Force and the Criminal Justice Coordinating Council's workgroups on juvenile justice and gun violence; the reviews and policy recommendations to address juvenile homicide made by the Child Fatality Review Committee; the number of children whose lives are affected by violence after leaving the care of District agencies; and the investigative and research efforts of the Metropolitan Police Department. The Committees will invite testimony from each of these organizations. The purpose of the hearing is to establish a baseline on the critical issue of youth violence and open a public dialogue on steps that should be taken by the District of Columbia

government and community to reduce youth violence. The hearing will be held in the Council Chamber and will begin at 10:00 a.m.

The public hearing is scheduled for Tuesday, February 8, 2005, at 11:00 a.m., in the Council Chamber, Room 500 of the John A. Wilson Building, 1350 Pennsylvania Avenue, N.W.

Bill 16-24, introduced by Councilmember Vincent Gray, would: close Blaine Street NE between 58<sup>th</sup> Street NE and East Capitol Street; close 58<sup>th</sup> Place NE, 59<sup>th</sup> Street NE, 59<sup>th</sup> Place NE, and 60<sup>th</sup> Place NE, between Blaine Street NE and East Capitol Street; close 57<sup>th</sup> Street SE between A Street SE and East Capitol Street; close 57<sup>th</sup> Place SE between A Street SE and 57<sup>th</sup> Street SE; close certain existing alleys; and create new streets and alleys to be dedicated to the District, in Ward 7. These proposed street and alley closings, dedications and designations would facilitate the development by the District of Columbia Housing Authority and A&R/THC, LLC, of a mixed use project consisting of 515 residential units, a community building with a day care center, and a new shopping center with a supermarket.

Council Chairman Linda W. Cropp announces a public roundtable by the Committee of the Whole on PR 16-47, the "Sense of the Council in Support of Inclusionary Zoning Requirements Resolution of 2005" The roundtable is scheduled for Tuesday, January 25, 2005, at 10:00 a.m., in the Council Chamber of the John A. Wilson Building, 1350 Pennsylvania Avenue, N.W.

PR 16-47 would declare the sense of the Council with respect to the need to amend the Zoning Regulations to adopt a mandatory inclusionary zoning policy that requires new and rehabilitated residential developments to include housing units affordable to low and moderate income residents in exchange for permitting housing developers to obtain additional zoning density or other compensation as a matter of right.

This public roundtable is a continuation of a public roundtable that was held by the Committee of the Whole on December 8, 2004, on an identical proposed resolution (PR 15-1194) in Council Period 15. At that time, the Committee heard testimony from the public; however, due to time constraints, the Committee did not hear testimony from the executive branch at that time. This roundtable is being reconvened to hear testimony from the executive branch on the proposed resolution, and the record from the previous roundtable, including all of the testimony presented last month, will be incorporated into the record on PR 16-47.
