Bill 16-126, the "Commercial Property Tax Credit Act of 2005" amends Chapter 8 of Title 47 of the District of Columbia Official Code to provide a tax credit to owners of commercial and non-owner-occupied residential real property to limit the amount of the real property tax to 5% growth from the real property tax for the prior tax year. This legislation seeks to alleviate tax burdens on District of Columbia small businesses and tenants who ultimately bear the burden of tax increases passed-down by property owners.

Bill 16-127, the "Disabled District Resident Tax Relief Act of 2005" amends Title 47 of the District of Columbia Official Code to provide a residential real property tax credit of 50% to disabled District residents with incomes are less than \$100,000 and to allow disabled residents with incomes are less than \$100,000 to exclude \$10,000 from the computation of income subject to taxation by the District of Columbia.

Bill 16-128, the "Senior Citizen Real Property Tax Deferral Act of 2005" amends Title 47 of the District of Columbia Code to provide for deferral of real property taxes for needy senior citizens on properties that are owned at least 50%, in whole or in part, by individuals who is 65 years of age or older and the individuals' household adjusted gross income is less than \$50,000.

Bill 16-37, the "Georgia Avenue Investment Now Amendment Act of 2005" amends Chapter 18 of Title 47 of the District of Columbia Official Code to establish a Georgia Avenue Investment Now district, to adjust the taxes on Georgia Avenue Investment Now businesses and properties; and to amend Chapter 15 of Title 47 to exempt the personal property of qualified businesses in the Georgia Avenue Investment Novalisation for a 10-year period.

Bill 16-73, the "Lot 146, Square 677 Partial Real Property Tax Exemption Continuation Act of 2005" extends the partial exemption from taxation of certain real property described for assessment and taxation purposes as lot 146, square 677, in the District of Columbia, and the buildings located thereon, owned by APA 750 LLC, a wholly owned subsidiary of the American Psychological Association, a District of Columbia non-profit corporation.

Bill 16-105, the "Mechanic's Lien Amendment Act of 2005" provides that only a properly licensed contractor may file a mechanic's lien; establishes separate requirements for filing a mechanic's lien on residential and commercial property; establishes greater notice requirements; and clarifies the rights and limitation of subcontractors filing mechanic's liens.

Bill 16-115, the "Standard and Itemized Deduction Filing Election Act of 2005" amends section 47-1803.03(c) of the District of Columbia Official Code to allow District of Columbia taxpayers to elect either the standard or itemized deduction, regardless of whether they itemized deductions on their federal income taxes.

Bill 16-139, the "Commercial Utility Tax Amendment Act of 2005" amends title 47 of the District of Columbia Official Code to eliminate the sales tax and to increase the gross receipts tax for commercial users of utilities.

Bill 16-140, the "Small Business Personal Property Tax Exemption Act of 2005" revises the tax imposed on personal property so as to exempt the personal property of any person, corporation or partnership with annual gross receipts of five hundred thousand dollars or less.
