Councilmember Carol Schwartz, Chair of the Committee on Public Works and the Environment, announces a Public Hearing on Bill 16-42, the "Hazardous Waste Notice and Penalty Amendment Act of 2005," Bill 16-110, the "District of Columbia Unattended Children in Motor Vehicle Safety Act of 2005," and Bill 16-119, the "Parking Amendment Act of 2005." The hearing will be held on Wednesday, May 18, 2005, at 10:00 a.m. in the Council Chamber (Room 500) of the John Wilson Building, 1350 Pennsylvania Avenue, N.W., Washington, D.C. 20004.

Bill 16-42, the "Hazardous Waste Notice and Penalty Amendment Act of 2005," introduced by Councilmember Fenty and co-sponsored by Councilmembers Barry, Gray and Mendelson, would amend the District of Columbia Hazardous Waste Management Act of 1977 to require that residents and businesses in the area affected by hazardous waste contamination are notified by the Mayor; require a person who discovers himself to be the generator of hazardous waste to notify the Mayor immediately; increase the maximum fines for a hazardous waste offense to \$50,000 for each violation and \$100,000 for each knowing violation; and specify that fines collected by the District shall be spent on the treatment of health and environmental dangers posed by the hazardous waste offense.

Bill 16-110, the "District of Columbia Unattended Children in Motor Vehicle Safety Act of 2005," introduced by Councilmember Orange and co-sponsored by Councilmember Ambrose, would require that a fine be imposed if a parent or caregiver leaves a child unattended in a motor vehicle.

Bill 16-119, the "Parking Amendment Act of 2005," introduced by Councilmembers Gray, Brown, Mendelson, Ambrose and Patterson and co-sponsored by Chairman Cropp and Councilmembers Graham and Fenty, would prohibit the parking of motor vehicles in the front yard on private property, give property owners a claim of title on abandoned and/or dangerous vehicles impounded from their property with their consent, and require that motor vehicle auctioneers maintain a record of vehicles sold by vehicle identification number and purchaser.
