
SUBJECT: Delegation of Authority pursuant to D.C. Law 2-64, the District of Columbia Hazardous Waste Management Act of 1977.

ORIGINATING AGENCY: Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(6) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22(6), and the District of Columbia Hazardous Waste Management Act of 1977, effective March 16, 1978, D.C. Law 2-64, D.C. Official Code §§ 8-1301 *et seq.* ("Act"), it is hereby **ORDERED** that:

1. The Director of the Department of Health is delegated the Mayor's authority to implement the Act including the authority to inspect and issue permits for the construction and operation of hazardous waste treatment and disposal facilities, develop a hazardous waste management plan for the District of Columbia, issue rules to implement the Act, and enforce the Act as set forth in sections 4 through 24 (D.C. Official Code §§ 8-1301 through 8-1322).
2. This Order shall supersede Mayor's Order 98-55, dated April 15, 1998.
3. **EFFECTIVE DATE:** This Order shall become effective immediately.

SUBJECT: Establishment – Mayor's Panel on Judicial Endorsements

ORIGINATING AGENCY: Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422 (2) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22 (2) (2001), it is hereby **ORDERED** that:

I. ESTABLISHMENT

There is hereby established in the Executive Office of the Mayor the Panel on Judicial Endorsements (hereinafter referred to as the "Panel").

II. PURPOSE

The Panel shall advise the Mayor concerning candidates for appointment to the federal and local courts in the District of Columbia with the objective of recommending to the Mayor those candidates whom he may wish to endorse for appointment.

III. FUNCTIONS

The functions of the Panel shall include:

- a. Advising the Mayor of candidacies for appointment as they become known to the Panel or members thereof.
- b. Reviewing information concerning the candidates as known to members of the Panel or as brought to their attention.
- c. Recommending to the Mayor whether he should endorse one or more candidates for a given judicial position, either by formal letter or by informal conversation with the nominating or appointing authority.
- d. Undertaking such other functions as the Mayor may assign from time to time or that may advance the purpose of the Panel.

IV. COMPOSITION

- a. The Panel shall be composed of the following government members, who shall serve for so long as they serve in the public offices described:
 1. Chief of Staff, Executive Office of the Mayor;
 2. Deputy Mayor for Public Safety and Justice;
 3. Attorney General of the District of Columbia;
 4. General Counsel, Executive Office of the Mayor.
- b. From time to time, the Mayor may designate such additional members of the Panel, either from elsewhere in the government or from the private sector, as the Mayor may deem appropriate to effectuate the purpose of the Panel.

V. TERMS

- a. The government members of the Panel shall serve at the pleasure of the Mayor or for the duration of their appointments to the government positions referred to in Paragraph IV, above, whichever ends sooner.
- b. Members of the Panel other than government members shall serve at the pleasure of the Mayor.

VI. COMPENSATION

- a. Government members of the Panel shall serve without compensation beyond that accorded them by virtue of the government positions they otherwise hold.
- b. Other members of the Panel shall serve without government compensation.

VII. ORGANIZATION

- a. The Chief of Staff of the Executive Office of the Mayor shall serve as Chair of the Panel.
- b. The Chief of Staff may designate such personnel from his or her office as may be necessary and appropriate to provide staffing to the Panel.
- c. The Panel may meet in public space owned or occupied by the District of Columbia government.


VIII. CONFIDENTIALITY

- a. Meetings and deliberations of the Panel shall be non-public to the extent permitted by law.
- b. Writings and electronic-mail traffic generated by the Panel or its members in the course of performing their duties pursuant to this Mayor's Order, and reports and recommendations of the Panel addressed to the Mayor, shall be deemed confidential to the extent permitted by law.

IX. EFFECTIVE DATE

This Order shall be effective immediately.



ORIGINATING AGENCY: Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422 (2) and (6) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22 (2) and (6) (2001), and pursuant to Title II of the Child and Youth, Safety and Health Omnibus Amendment Act of 2004 (the "Act"), effective April 13, 2005 (D.C. Law 15-353), it is hereby **ORDERED** that:

1. The Director, D.C. Office of Personnel, is delegated the authority vested in the Mayor in section 211 of Title II of the Act to issue rules governing the criminal background check requirement for persons being considered for compensated or voluntary employment in positions in District government agencies that meet the definition of "covered child or youth services provider," as the term is defined in section 202 (3) of the Act, as well as rules governing the periodic criminal background check requirement in section 203 of Title II of the Act.
2. The Director, D.C. Office of Personnel, is delegated the authority vested in the Mayor in section 204 of Title II of the Act, to conduct traffic record checks for individuals covered by the Act who are required to drive a motor vehicle to transport children and youth in the course of performing their duties.
3. The Chief Procurement Officer, Office of the Chief Procurement Officer, is delegated the authority vested in the Mayor in section 211 of Title II of the Act to issue rules governing the criminal background check requirement and the traffic record check requirement for persons and private agencies considered for contractual work as covered child or youth services providers pursuant to the Act.
4. The Chief, Metropolitan Police Department, is delegated the authority vested in the Mayor to conduct criminal background checks under sections 203 and 205 of Title II of the Act, for agencies subordinate to the Mayor that are covered under the Act.
5. The heads of the following covered agencies, and the Executive Director in the case of the State Education Office of the Executive Office of the
