**Notice of Reprogramming Disapproval**

Chairman Gray filed on May 28, 2008, PR 17-805 the "Reprogramming No. 17-108 Disapproval Resolution of 2008" to disapprove Reprogramming 17-108. The request to reprogram \$15,000,000 of capital budget authority from the Office of Public Education Facilities Modernization (OPEFM) to the District of Columbia Public Schools (DCPS) for 13 Information Technology (IT) projects to be implemented by the Office of the Chief Technology Officer (OCTO) in close consultation with representatives of the Chancellor of DCPS, the agency that will own the IT projects was filed in the Chairman's Office on May 14, 2008. The approval resolution extends the Council's review period to Friday, June 13, 2008. If the Council does not adopt a resolution of approval or disapproval during this period, the reprogramming will be deemed approved on Saturday, June 14, 2008.
