Pursuant to D.C. Law 11-134, D.C. Code Section 2-1215.01, et seq, Deputy Mayor Stanley Jackson announces a Public Hearing on the matter of the application from the Adams Morgan Partnership to establish the Adams Morgan Business Improvement District. On June 21, 2005, Deputy Mayor Jackson sent a letter to the Adams Morgan Partnership in which he determined that the filing criteria set forth in D. C. Code Section 2-1215.04 have been met and that the application is in conformity with the law. This public hearing will determine whether or not the BID application meets the purposes of the BID law, the definition of BID activity and all other BID application requirements.
