On July 11, 2005, the Office of Zoning received an application from Level 2 Development, LLC (the “applicant”). The applicant is requesting from the Zoning Commission approval of a consolidated PUD for property known as 2301-15 14th Street, N.W.

The property that is the subject of this application consists of Square 2868, Lot 119 and a portion of Lot 122 in Northeast Washington, D.C. (Ward 1), at the east side of 14th between Florida Avenue and Belmont Street. The property is zoned C-2-B.

The applicant proposes to develop a mixed-use development of residential, retail, and service uses composed of approximately 174,006 feet of residential use, or 170 condominium units, a portion of which will be devoted to affordable housing, approximately 16,634 square feet of retail use, an underground parking garage with approximately 150 spaces, and a floor area ratio of approximately 6.0. Also, in connection with this project, the Applicant has created an affordable program for on-site and off-site affordable housing. This request is not inconsistent with the Comprehensive Plan of the District of Columbia.
