On September 16, 2005, Councilmember Adrian Fenty, Chairperson of the Committee on Human Services, will convene a public oversight hearing on contracts for the Department of Human Services, including CA 16-111, a proposed contract modification with the Community Partnership for the Prevention of Homelessness in the amount of \$7,046,244.75. The modification would increase the value of the current contract with the Community Partnership by \$2,050,275.00 in FY 2005 funds for additional services and by \$4,995,969.75 in FY 2006 funds for an extension of the contract the term from September 30, 2005, until December 31, 2005. On August 8, 2005, the Mayor submitted CA 16-111 for Council review; a resolution of disapproval was introduced, extending the Council review period to 45 days from the date of submission. The hearing will also include a discussion of contracts related to the TANF Employment Program that are expected to be submitted to the Council prior to the hearing.

The hearing will be held in Room 412 and will begin at 3:00 p.m. The Committee invites the public to testify in person or in writing. Anyone wishing to testify at the hearing should contact William Singer at 724-8107 or via email at wsinger@dccouncil.us. Witnesses will be permitted three minutes for oral presentation and are asked to bring 20 copies of their written statements. Persons unable to testify at the hearing are encouraged to submit written testimony for inclusion in the official record. NOTICE OF CONTRACT DISAPPROVAL RESOLUTION

The Council of the District of Columbia gives notice that the resolution listed below to disapprove CA 16-111, proposed contract was filed in the Office of the Secretary on August 18, 2005. CA 16-111 with the Community Partnership for the Prevention of Homeless was filed in the Office of the Secretary on August 8, 2005. The proposed contract in the amount of \$7,046,244.75 is to provide homeless service for families and single adults. The disapproval resolution extends the Council's review period to 45 days, including Saturday, Sundays, and legal holidays. If a resolution of approval or disapproval is not adopted by the Council during this time, the proposed contract will be deemed approved on the 46th day.
