The Applicant also requests certain modifications from the conditions applicable to the preliminary and consolidated PUDs in Order No. 03-12/-03-13. The Applicant proposes to: (1) allow purchasers of the fourteen foot wide and sixteen foot wide residential units to have the option to change the two car garage to a one car garage and a first floor recreation room; (2) related to No. (1), reduce the approved parking requirements for some of the low-rise residential structures from 2 spaces per unit to 1 space per unit; (3) increase the overall residential density from 2.21 FAR to 2.34; (4) change the timing of the application for a building permit for the community center to eight months after the issuance of the Zoning Commission's order approving the community center; (5) increase the height of the community center to 35 feet and reduce the setback requirements for its roof structure, and; (6) move the location of 3rd Place approximately fourteen feet to the east of the location shown on the approved plans, and reduce open court widths in Square 799 so as to eliminate the need for the Applicant to acquire private homes in Square 798

If an affected Advisory Neighborhood Commission (ANC) intends to participate at the hearing, the ANC shall submit the written report described in § 3012.5 no later than seven (7) days before the date of the hearing. The report shall also contain the information indicated in (e) through (h) above.

Time limits.

The following time limits for oral testimony shall be adhered to unless changed by the Commission, and no time may be ceded:
