To approve the amendments to the rules governing the procurement of goods and services for the District of Columbia Retirement Board.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "District of Columbia Retirement Board Procurement Rules Amendment Approval Resolution of 2005".

Sec.2. Pursuant to the authority set forth in section 121(i)(2) of the District of Columbia Retirement Reform Act, approved November 17, 1979 (93 Stat. 866; D.C. Code § 1-711(i)(2)), the District of Columbia Retirement Board, on May 25, 2005 transmitted to the Council amendments to its procurement rules to update the limits for various categories of procurements to the levels of other District agencies, and to accommodate the expanded scope of responsibilities tha the Board is taking on for administration of retirement benefits.

Sec. 3. The Council of the District of Columbia has a 45-day review period. If the Council does not approve or disapprove the proposed procurement rules, in whole or in part, by resolution within the 45-day review period.
