WHEREAS, Shoshana Nyree Johnson joined the United States Army in September 1998;

WHEREAS, Shoshana Nyree Johnson completed both the U. S. Army Basic Training Course at Fort Jackson, South Carolina, advanced Individual Training at Fort Lee, Virginia, and served at Fort Bliss, Texas;

WHEREAS, Shoshana Nyree Johnson was with the 507<sup>th</sup> Maintenance Company, 552 Battalion 11<sup>th</sup> Brigade serving as a Food Service Specialist when she was deployed to Iraq in February 2003;

WHEREAS, Shoshana Nyree Johnson was shot in her right ankle, causing injuries to both legs when the convoy she was with was attacked by ambush in an - Nasiriyah during Operation Iraqi Freedom on March 23, 2003;

WHEREAS, Shoshana Nyree Johnson and seven members of the 507<sup>th</sup> Maintenance Company were captured and taken as Prisoners of War ("POW");

WHEREAS, Shoshana Nyree Johnson was identified by the U. S. Army as the first black female POW in U. S. War history;

WHEREAS, Shoshana Nyree Johnson has further been recognized by the President of the Republic of Panama, the Congressional Hispanic and Black Caucuses, Rainbow PUSH Coalition, Glamour Magazine, McDonald's, NYSE, NAACP of El Paso, colleges, universities, churches and NYPD.

WHEREAS, Dr. Forman served as the Executive Secretary of the Student Nonviolent Coordinating Committee (SNCC), and participated in voter education efforts in Selma Alabama, and elsewhere, that aided in the signing of the 1965 Voting Rights Act which aided Black people and others to be elected to political office;

WHEREAS, Dr. Forman founded and continues to lead the Unemployment and Poverty Action Committee (UPAC), a nonprofit organization seeking to encourage voter education throughout the United States;

WHEREAS, Dr. Forman's steadfast career of service has significantly helped to frame history through his national and international crusade for desegregation, equal employment and education, affirmative action and de-colonization;

WHEREAS, Dr. Forman organized housing, feeding, tutoring and employment programs for poor people, farmers, sharecroppers, and the illiterate;

WHEREAS, Dr. Forman also helped to organize the Albany Movement, a nonviolent bus desegregation campaign, and the Mississippi Freedom Project, a voter registration and education campaign, the result of which was the registration of thousands of African-American voters and the establishment of over 80 Freedom Schools;

WHEREAS, Dr. Forman was a principal organizer of the 1963 March on Washington for Jobs and Freedom, his involvement in the Civil Rights movement - through leading numerous peaceful marches, protests, rallies, sit-ins, and freedom rides - significantly contributing to the landmark Civil Rights Act of 1964, despite the routine backlash he suffered through harassment, death threats, physical violence and jailing;

WHEREAS, the selfless sacrifices of Dr. Forman contributed in part to the passage of the Voting Rights Act of 1965, which enabled African-Americans and others to have a voice in local, state, and national politics, countering the intimidation, assaults, and economic reprisals that were common place when African-Americans attempted to register to vote in the Deep South;

WHEREAS, Dr. Forman was the first person in U.S. history to file papers to run for the position of U.S. Senator from the District of Columbia;
