By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(2) and (3) of the District of Columbia Home Rule Act, as amended, 87 Stat. 790, D.C. Official Code § 1-204.22 (2) and (3) (2001) and the District of Columbia Government Comprehensive Merit Personnel Act of 1978 (hereinafter referred to as the "CMPA"), effective March 3, 1979 (D.C. Law 2-139, D.C. Official Code §§ 1-601.01 *et seq.*) (2001), it is hereby **ORDERED** that:

- A. Notwithstanding Paragraphs A and B of Mayor's Order 2000-83, dated May 30, 2000, the Director of the D.C. Office of Personnel and the Chief of the Fire and Emergency Medical Services Department are jointly delegated the authority vested in the Mayor under § 406 (b) of the CMPA, (D.C. - B. All activities associated with the joint delegation of personnel authority specified in Paragraph A of this Order shall be conducted in accordance with the applicable provisions in the CMPA and the D.C. Personnel Regulations.



**SUBJECT:** Establishment of the Office of Victim Services

**ORIGINATING AGENCY:** Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia pursuant to sections 422(2), 422(6), and 422(11) of the District of Columbia Home Rule Act of 1973, as amended, Pub. L. No. 93-198, 87 Stat. 790; D.C. Official Code §§ 1-204.22(2), (6), and (11) (2001), it is hereby **ORDERED** that:

**1. ESTABLISHMENT**

There is hereby created an office to be known as the Office of Victim Services ("the Office") in the Office of the Deputy Mayor for Public Safety and Justice (the "Deputy Mayor").

**2. PURPOSE**

The Office shall be responsible for supporting and coordinating the development and implementation of a comprehensive system of care for crime victims within the District of Columbia. The Office will also focus on the planning for, and the administration and monitoring of, all victim-service related federal funds, including the Crime Victim Assistance Fund, Victims of Crime Act Grant Programs, Office on Violence Against Women Grant Programs, and any grant program created for the purpose of serving the crime victim community.

**3. FUNCTIONS**

The Office, by coordinating functions to be carried out by program agencies, shall:

- a. Represent the Administration on issues concerning victims of crime;
- b. Advocate on behalf of victims of crime on issues related to services, systems response, legislation, and resource allocations at all levels of the government and the community;
- c. Review, evaluate and make recommendations concerning the District's response to victims, outreach and education on victims' issues, capacity building for victims' services, training for responders and any legislation that affects victims of crime;


- d. Produce an annual report that provides an update on the use of crime victims' funds and recommendations concerning goals, priorities and strategies for improvement of services to victims;
- e. Assist with the development of legislation, policies, plans, programs, and budgets to ensure consistent and effective systems response to victims;
- f. Provide technical assistance;
- g. Identify new sources of funding and provide assistance to District agencies and community programs in obtaining such funds;
- h. Promote outreach and education efforts concerning crime issues and resources available to assist victims;
- i. Work in partnership with community leaders, educators, religious leaders, social service agencies, businesses, and the public to identify and address issues facing victims of crime;
- j. Facilitate the participation of citizens, community organizations and district agencies in planning activities; and
- k. Perform other duties as assigned.

#### 4. ORGANIZATION

The Office shall be headed by a Director, who shall report to the Deputy Mayor. The Director is hereby authorized to exercise the Mayor's authority to apply for and to accept grant funding under section 417 of the District of Columbia Appropriations Act, 2004, approved January 23, 2004, Pub. L. 108-199, and any substantially identical successor law. To the extent required by applicable law, the Office (i) will advise the Office of the Chief Financial Officer of applications for grant funds and their distribution and (ii) will seek approval from the Council of the District of Columbia in applying for and distributing grant funds. The Director shall coordinate, hire, and supervise all staff of the Office as needed to complete the mission, subject to the concurrence of the Deputy Mayor.

#### 5. EFFECTIVE DATE

This Order shall become effective immediately and shall supersede Mayor's Order 2004-97, dated June 4, 2004, to the extent of any inconsistency.





SUBJECT: Establishment – Ex-Offender Re-Entry Initiative

ORIGINATING AGENCY: Executive Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(4) and (11) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22(4) and (11) (2001), it is hereby **ORDERED** that:

**I. ESTABLISHMENT**

There is hereby established in the Executive Office of the Mayor the District of Columbia Ex-Offender Re-Entry Initiative (hereinafter referred to as the "EOREI" or the "Initiative").

**II. FINDINGS**

- More than 7,000 District of Columbia residents are currently incarcerated, and a majority of these individuals are serving their time in federal correctional institutions.
- Because approximately 2,500 ex-offenders return to the District every year, the District should develop collaborative efforts to help ex-offenders make the transition back into their communities.
- The District government has applied for and received a \$2 million grant from the U.S. Department of Justice to fund a re-entry pilot program that will serve 205 qualifying ex-offenders.
- Local and federal stakeholders have formed a lead advisory body, the D.C. Re-Entry Planning Committee, that can help to implement the Initiative. A number of local and federal agencies are involved in this effort.
- The Initiative will include the efforts of those agencies involved in the advisory body and other local and federal agencies, as follows:

Office of the Deputy Mayor for Children, Youth, Families and Elders;

Office of the Deputy Mayor for Public Safety and Justice;  
Court Services and Offender Supervision Agency, (CSOSA);  
Criminal Justice Coordinating Council;  
U.S. Bureau of Prisons;  
Office of Justice Programs, U.S. Department of Justice;  
Department of Human Services;  
Department of Employment Services;  
Department of Mental Health;  
Department of Housing and Community Development; and  
Department of Health.

### III. PURPOSE AND GOALS:

The EOREI shall function as a model effort to bring together all available resources to meet the needs of participating ex-offenders by integrating employment services with a full range of human and support services. The EOREI shall have five fundamental goals:

- To prevent re-offending;
- To enhance public safety;
- To re-deploy and leverage existing community resources;
- To assist ex-offenders to avoid crime by engaging ex-offenders in pro-social community activities; and
- To help ex-offenders meet their family responsibilities.

### IV. DUTIES AND FUNCTIONS

The major goals of the EOREI are to assist in providing and promoting intensive support services that will promote positive life and career goals for ex-offenders and that will strengthen and secure their long-term futures. Specific activities include the following:


- A. Provision of infrastructure for coordination and efficient delivery of ex-offender focused services in the District;
- B. Assessment of the need and submission of recommendations for additional ex-offender policies and programs to District government agencies;
- C. Expansion of public awareness efforts regarding the importance of viable educational and career opportunities for ex-offenders in the District;


- D. Collaboration with private and non-profit organizations, including faith-based organizations, in the promotion of viable opportunities for ex-offenders;
- E. Identification of obstacles that prevent improvement efforts for ex-offenders and recommendations for eliminating those obstacles; and
- F. Assistance in public presentations regarding the Initiative's goals and accomplishments.

V. ADMINISTRATION

The Office of the Deputy Mayor for Children, Youth, Families and Elders shall provide administrative support to the EOREI. The Deputy Mayor shall designate a member of his staff to act as the EOREI coordinator and to monitor service delivery, ensure that services are identified and provided in a timely manner, and incorporate the resources provided by community service agencies.


**SUBJECT:** Delegation of Mayor's Authority to the Director of the Department of Motor Vehicles to Issue Environmental Identification Tags.

**ORIGINATING AGENCY:** Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(6) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22 (6) (2001), and section 2 of the Environmental License Tag Amendment Act of 2000, effective October 21, 2000, D.C. Law 13-182, D.C. Official Code § 50-801 (2001) ("Act"), it is hereby **ORDERED** that:

1. The Director of the Department of Motor Vehicles, or his or her designee, is delegated the authority vested in the Mayor pursuant to § 2 of the Act to issue environmental identification tags, provided that proceeds from the issuance of the tags shall be used for the District's environmental protection activities. (D.C. Official Code § 50-801(a).)
2. The Director of the Department of Motor Vehicles, or his or her designee, is delegated the authority to establish a one-time reservation fee for the environmental identification tags and souvenir environmental identification tags. (D.C. Official Code § 50-801(b).)
3. The Director of the Department of Motor Vehicles, or his or her designee, is further delegated the authority vested in the Mayor to have final approval of the design of the environmental identification tags. (D.C. Official Code § 50-801(a).)

Commencing September 1, 2004, through September 2, 2004, daily from 6:00 a.m. until 10:00 p.m., the streets known as "E" Street, N.W., and Pennsylvania Avenue, N.W., between 13<sup>th</sup> & 14<sup>th</sup> Streets, N.W., being those streets immediately to the north and south of Freedom Plaza, together with Freedom Plaza, are hereby designated as special event areas to be used as a senior vending marketplace and senior festival site. The said portion of E Street shall be closed to motor vehicle traffic except for such vehicles as may be expressly authorized to enter therein, and the said portion of Pennsylvania Avenue shall be partially closed to motor vehicle traffic as necessary to facilitate the loading and offloading of attendees, materials and supplies to Freedom Plaza.
2. The D.C. Office on Aging ("DCOA") is authorized to operate said senior festival and senior vending marketplace in this designated special event area, at the times specified.
3. In the event that all or any part of the said senior festival is interrupted by adverse weather conditions on September 1 or 2, 2004, DCOA hereby is authorized to extend the said senior festival to September 3, 2004, under the terms and conditions described in Paragraph 1, above.
4. **EFFECTIVE DATE:** This Order shall become effective immediately.




**SUBJECT:** Delegation of Authority to the Chief Financial Officer under the Master Equipment Lease Program
