By virtue of the authority vested in me as Mayor of the District of Columbia pursuant to section 422(2) of the District of Columbia Home Rule Act of 1973, as amended, Pub. L. No. 93-198, 87 Stat. 790, D.C. Official Code § 1-204.22(2) (2001 ed.), it is hereby **ORDERED** that:

1. Robert C. Bobb, City Administrator, shall assume the responsibilities and exercise the authority of the Deputy Mayor for Public Safety and Justice ("DMPSJ") at the pleasure of the Mayor while continuing to serve as City Administrator.
2. All prior Mayor's Orders relating to the authority and responsibilities of the DMPSJ are superseded to the extent of any inconsistency with this Order.
3. **EFFECTIVE DATE.** This Order shall be effective June 6, 2004. This Order shall remain in effect until superseded, in whole or in part, by further Mayor's Order.


SUBJECT: Appointment – Washington Convention Center Authority Board of Directors
