Bill 15-670, the "District of Columbia Emancipation Day Parade and Fund Act of 2004" would establish the Emancipation Day Parade and related activities to celebrate and commemorate District of Columbia Emancipation Day and to establish the Emancipation Day Fund to accept and use gifts for the purpose of funding the Emancipation Day Parade.

Bill 15-827, the "District of Columbia Emancipation Day Amendment Act of 2004" proposes to amend the District of Columbia Government Comprehensive Merit Personnel Act of 1978 to make April 16th, the District of Columbia Emancipation Day, a recognized legal public holiday.

Bill 15-718, the "Ceremonial Funds Amendment Act of 2004" would authorize the appropriation of not more than \$100,000 annually for funds for ceremonies in the

District of Columbia by the Mayor and by the Council, and to authorize the Mayor and the Council to accept, administer, and use gifts or donations for this purpose.

Councilmember Phil Mendelson, Chairman of the Subcommittee on Public Interest announces a public roundtable on the Bill 15-872, the "Omnibus Utility Amendment Act of 2004." The public roundtable will be held at 11:00a.m. on Thursday, July 1, 2004 in Room 412 of the John A. Wilson Building, 1350 Pennsylvania Avenue, N.W. Washington, D.C. 20004.

Bill15-872 proposes to increase Commissioner salaries at the Public Service Commission and the following changes to Title 34 of the D.C. Code: (1) changing the five-year limitation for PSC nominees prior to appointment having a financial or other interest in a public utility to one-year; (2) requiring the Commission and Office of the People's Counsel to expeditiously refund the balance of any funds received pursuant to § 34-912(a); (3) increasing the expenditure cap for OPC and the Commission under § 34-2002(m); (4) establishing a minimum non-bypassable charge under § 34-1514 and requiring the Commission to commence collection on January 1, 2005; (5) requiring public utilities to notify both the Office of the People's Counsel and Commission and submit a written incident report in the event of injury, death or interruption in service; (6) requiring the Commission and OPC to submit the agency fund reports by February 15th of each year and to provide copies to the public utilities; (7) clarifying that notice under the Utility Ratepayers Amendment Act of 2004 can be by electronic or written means; and (8) for other purposes.

Councilmember Sharon Ambrose, Chairperson of the Committee on Consumer and Regulatory Affairs, announces a Public Roundtable on the permitting process for the Shell Hydrogen Tanks Project, 3355 Benning Road, NE. The Public Roundtable will be held on Wednesday, June 30, 2004, at 11:00 am in Room 123 at the John A. Wilson Building, 1350 Pennsylvania Avenue, NW, Washington, DC 20004.

The purpose of the Public Roundtable is to review whether the District government followed its permitting process properly for the Shell Hydrogen Tanks Project at 3355 Benning Road, NE. This Project involves the conversion of a Texaco gasoline station at this address into a Shell service station which would offer both gasoline fuel and hydrogen fuel for the experimental HydroGen3 fuel cell cars manufactured by General Motors. This is part of a pilot demonstration project exploring the development and use of alternative fuels. According to a Spring 2004 company newsletter, the company sought 3 permits from the Department of Consumer and Regulatory Affairs. The third permit was for upgrading the gasoline dispensing systems and installing hydrogen storage and dispensing facilities – the first of these alternative fuel facilities in the District. A “stop work” order was placed on this permit on March 3rd until an Environmental Impact Screening Form (EISF) was submitted and reviewed by the relevant agencies. A completed EISF was submitted to DCRA on March 19th. The Roundtable will review this entire process.
