Councilmember Sandra (Sandy) Allen, Chairperson of the Committee on Human Services, announces a public hearing to receive comments on Bill 15-721, the "Lead-Based Paint Abatement and Control Amendment Act of 2004." The hearing will be held on Thursday, May 13, 2004 at 10:00 a.m. in Room 412 at 1350 Pennsylvania Avenue, N.W. This hearing will be a continuation of the public roundtable held on March 10, 2004, which was recessed by Councilmember Allen because the Department of Health did not have the necessary personnel in attendance to sufficiently address concerns raised at the roundtable.

Bill 15-721, the "Lead-Based Paint Abatement and Control Amendment Act of 2004," amends the Lead-Based Paint Abatement and Control Amendment Act of 1996 to change exemptions and increase criminal and civil penalties and fines for violations to match federal standards and amends the Housing Regulations of the District of Columbia to require notice of peeling paint.

The Committee extends an invitation to the public to testify at the hearing. Members of the public may also submit written testimony that will be made part of the official record. Written statements may be submitted by e-mail or mailed to Council of the District of Columbia; 1350 Pennsylvania Ave., N.W.; Suite 408; Washington D.C. 20004.

Witnesses should bring **20 copies** of their written testimony to the hearing. Individuals will be limited to three minutes and panels will be limited to five minutes for oral presentations, in order to permit each witness an opportunity to be heard.

The hearing record will close ten days following the conclusion of the hearing. Persons submitting written statements for the record should observe this deadline.
