WHEREAS, Maury Wills went on to lead the National League in stolen bases for 6 straight seasons, from 1960 to 1965, earning a lifetime total of 586 stolen bases;

WHEREAS, Wills, a major force on the winning Los Angeles Dodger team for 14 years who helped lead the Dodgers to 3 World Series' victories, in 1959, 1963, and 1965, ended his professional career in 1972, after having played baseball for 23 years;

WHEREAS, Maury Wills has been a trainer for more than 15 different major league teams, teaching the art of base stealing and running, was the Chairman of Athletics for Youth in the State of California under former Governor Ronald Reagan; worked as assistant to Pittsburgh's Mayor Barr in Youth Relations; served as assistant to the District Attorney of Clark County, Nevada for youth programs; and is currently a coach with the Dodgers; and

WHEREAS, Maury Wills will teach a baseball clinic for the second year in connection with this year's Second Annual Maury Wills Invitational Baseball Tournament, held at the baseball field adjacent to the Banneker Recreation Center on the 2500 block of Georgia Avenue, N.W., in Ward One, on April 5, 6, and 7, 2004, and sponsored by his alma mater Cardozo Senior High School.
