

Following the signature of the Mayor on July 29, 2003, pursuant to Section 404(e) of the Charter, the bill became Act 15-112 and was published in the August 15, 2003 edition of the D.C. Register (Vol. 50, page 6574). Act 15-112 was transmitted to Congress on September 4, 2003 for a 60-day review, in accordance with Section 602(c)(2) of the Home Rule Act.






