To recognize and honor Mary E. "Molly" Raphael on the occasion of her retirement from the District of Columbia Public Library.

WHEREAS, Molly Raphael began work on September 23, 1970 as an Assistant Children's Librarian at the Chevy Chase Neighborhood Library;

WHEREAS, Ms. Raphael continued her career in various positions at the Martin Luther King Jr. Memorial Library, including Librarian in the Biography Division, Chief of the Telephone Reference Division, Chief of the Philosophy Division and Assistant Martin Luther King Librarian;

WHEREAS, Ms. Raphael served as Assistant to the Director and Assistant Director for Program and Support Services, and during this time was instrumental in the establishment of many important programs including; Deaf Awareness, the District of Columbia Center for the Book, the Council of Librarians, Friends of the Library organizations and provided considerable support during the formation of the District of Columbia Public Library Foundation and fund-raising efforts for the King Mural.

WHEREAS, Ms. Raphael was appointed Acting Director in 1997 and Director and State Librarian in 1998;

WHEREAS, during Ms. Raphael's tenure as Director her accomplishments include the first-ever strategic planning process for the District of Columbia Public Library, developing a Master Facilities Plan (the first in over 30 years for District of Columbia Public Library), developing partnerships with other public and private sector entities such as the Enhanced Business Information Center with the United States Small Business Administration and the District of Columbia Economic Development Cluster, "DC Reads to Babies" with District of Columbia hospitals;

WHEREAS, Ms. Raphael also established and co-chaired a Labor Management Partnership Council at the District of Columbia Public Library that has received many awards in recognition of its success in promoting cooperative efforts by labor and management to improve the operation and services of the District of Columbia Public Library;

WHEREAS, Ms Raphael has demonstrated through her exceptional commitment and dedicated service to the citizens of the District of Columbia for over thirty-three years her passion for the importance of libraries and library services to the social and economic vitality of the city.

WHEREAS, LCCA organized a Christmas House Tour of area homes to celebrate the rich and diverse past of the neighborhood. The Logan Circle neighborhood includes both elegant Victorian era homes and the city's first "Auto Row" along 14th Street;

WHEREAS, Mary McLeod Bethune, founder of the National Council of Negro Women, is one of Logan Circle's most famous historic residents and her home is a national park site; and
