## D.C. LAW 15-39

**"Fiscal Year 2004 Budget Support Act of 2003"**

Pursuant to Section 412 of the District of Columbia Home Rule Act, P.L. 93-198 (the Charter), the Council of the District of Columbia adopted Bill 15-218 on first and second readings May 6, 2003 and June 3, 2003, respectively. Following the signature of the Mayor on June 20, 2003, pursuant to Section 404(e) of the Charter, the bill became Act 15-106 and was published in the July 18, 2003 edition of the D.C. Register (Vol. 50, page 5668). Act 15-106 was transmitted to Congress on July 7, 2003 for a 60-day review, in accordance with Section 602(c)(2) of the Home Rule Act.

The Council of the District of Columbia hereby gives notice that the 60-day Congressional review period has ended, and Act 15-106 is now D.C. Law 15-39, effective November 13, 2003.



Pursuant to Section 412 of the District of Columbia Home Rule Act, P.L. 93-198 (the Charter), the Council of the District of Columbia adopted Bill 15-310 on first and second readings July 8, 2003 and September 16, 2003, respectively. Following the signature of the Mayor on September 30, 2003, pursuant to Section 404(e) of the Charter, the bill became Act 15-150 and was published in the October 17, 2003 edition of the D.C. Register (Vol. 50, page 8700). Act 15-150 was transmitted to Congress on October 3, 2003 for a 30-day review, in accordance with Section 602(c)(1) of the Home Rule Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional review period has ended, and Act 15-150 is now D.C. Law 15-40, effective November 26, 2003.

Pursuant to Section 412 of the District of Columbia Home Rule Act, P.L. 93-198 (the Charter), the Council of the District of Columbia adopted Bill 15-324 on first and second readings July 8, 2003 and September 16, 2003, respectively. Following the signature of the Mayor on September 30, 2003, pursuant to Section 404(e) of the Charter, the bill became Act 15-151 and was published in the October 17, 2003 edition of the D.C. Register (Vol. 50, page 8704). Act 15-151 was transmitted to Congress on October 3, 2003 for a 30-day review, in accordance with Section 602(c)(1) of the Home Rule Act.
