

**"Central Detention Facility Monitoring  
Temporary Amendment Act of 2003"**

Pursuant to Section 412 of the District of Columbia Home Rule Act, P.L. 93-198 (the Charter), the Council of the District of Columbia adopted Bill 15-237 on first and second readings April 1, 2003 and May 6, 2003, respectively. The legislation was deemed approved without the signature of the Mayor on May 16, 2003, pursuant to Section 404(e) of the Charter, the bill became Act 15-81 and was published in the May 30, 2003 edition of the D.C. Register (Vol. 50, page 4093). Act 15-81 was transmitted to Congress on May 22, 2003 for a 60-day review, in accordance with Section 602(c)(2) of the Home Rule Act.


