ORIGINATING AGENCY: Executive Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia pursuant to section 422(2) of the District of Columbia Home Rule Act of 1973, as amended, approved December 24, 1973, 87 Stat. 790, Pub. L. No. 93-198; D.C. Official Code § 1-204.22(2) (2001), it is hereby **ORDERED** that:

1. Herbert R. Tillery is appointed Interim City Administrator of the District of Columbia and shall serve in that capacity at the pleasure of the Mayor, effective September 13, 2003, or upon the resignation of John A. Koskinen from the position of City Administrator of the District of Columbia, whichever shall first occur.
2. Herbert R. Tillery shall cease to serve as Interim City Administrator of the District of Columbia on October 5, 2003, or upon the assumption of the duties of the City Administrator by Robert C. Bobb, whichever shall last occur.
3. Herbert R. Tillery shall at all times continue to serve in his present position as Deputy Mayor for Operations.
4. This Order supercedes Mayor's Order 2000-145, dated September 25, 2000.
5. This Order shall become effective immediately.

SUBJECT: Amendment to Mayor's Order 2003-96, dated July 24, 2003; Citizen Summit

ORIGINATING AGENCY: Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia pursuant to section 422(6) and (11) of the District of Columbia Home Rule Act of 1973, approved December 24, 1973, 87 Stat. 790, Pub. L. 93-198, D.C. Official Code § 1-204.22(6) and (11) (2001), and section 115 of the District of Columbia Appropriations Act, 2003, approved February 20, 2003, Pub. L. 108-7 (and any substantially identical successor law), it is hereby **ORDERED** that:

1. Paragraph 1 of Mayor's Order 2003-96, dated July 24, 2003, is amended to read as follows:

"Notwithstanding Mayor's Order 2002-2, dated January 11, 2002, the authority to solicit and receive gifts and donations to support the Citizen Summit III is hereby delegated to the Executive Director, Neighborhood Action, Executive Office of the Mayor, each Deputy Mayor, and the Chief of Staff to the Mayor. This authority may, in turn, be delegated to other individuals who are under the respective supervision of the Executive Director, Neighborhood Action, a Deputy Mayor and the Chief of Staff to the Mayor. The use of gifts and donations solicited and received hereunder shall require the approval of the Director of the Office of Partnerships and Grants Development. Gifts and donations solicited and received under this Order shall be used solely to supplement the authorized budget of the EOM for FY2003 and, after its approval, the authorized budget of the EOM for FY2004 with respect to holding the Citizen Summit III."



SUBJECT: DECLARATION OF PUBLIC EMERGENCY


ORIGINATING AGENCY: Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia pursuant to section 422(11) of the District of Columbia Home Rule Act, as amended, Pub. L. No. 93-198, 87 Stat. 790, D.C. Official Code § 1-204.22(11), and the District of Columbia Public Emergency Act of 1980, effective March 5, 1981, D.C. Official Code §§ 7-2301 et seq., and based on the most recent severe weather condition impacting the District of Columbia, it is hereby **ORDERED** that:

1. A state of Public Emergency is declared in the District of Columbia effective immediately and continued until further notice, not to exceed 15 days. This public emergency declaration is a preparation for response to and recovery from the impacts of Hurricane Isabel. The impact of this fast approaching hurricane is forecasted to threaten the health, safety and welfare of residents of the District and requires emergency and protective actions.
2. The District of Columbia Response Plan (DRP) is hereby implemented.
3. The Chief Financial Officer of the District of Columbia is authorized to approve the disbursement of all appropriations necessary to carry out this Order.
4. The Director of the Emergency Management Agency is authorized to implement those provisions of the District Response Plan, as approved by the Mayor, that are necessary to carry out this Order.
5. This Order shall apply to all departments, agencies and instrumentalities of the District government in activating Emergency Support Functions (ESF) as provided in the DRP.
6. **EFFECTIVE DATE:** This Order shall remain in effect until further notice, not to exceed 15 days and becomes effective immediately.
