Councilmember Harold Brazil, chairperson of the Committee on Economic Development, announces a public hearing on Bill 15-193, the "District of Columbia Cultural, Arts, Recreation and Education (CARE) Facilities Support Act of 2003", Bill 15-415, the "Cultural, Arts Recreation and Education Investment Act of 2003", and Bill 15-145, the "District of Columbia Support for the Arts Act of 2003". The public hearing will be held at 4:00 p.m. on Thursday, October 23, 2003, in Room 412 at 1350 Pennsylvania Avenue, NW.

Bill 15-193 would authorize the Mayor to provide loans, grants, and other forms of economic assistance for the construction and rehabilitation of facilities used by certain not-for-profit organizations to develop, produce, conduct and promote cultural, artistic, recreational, and educational activities. Bill 15-415 would amend Title 47 of the District of Columbia Official Code to impose a tax on the sale of certain tickets of admission and would authorize the Mayor to use the revenues generated by such a tax and other resources of the District to provide assistance to certain not-for-profit organizations to develop, produce, conduct, and promote cultural, artistic, recreational, and educational activities and to authorize the provision of economic assistance to Arena Stage. Bill 15-145 would authorize the Mayor to make grants to certain arts organizations for capital costs incurred in the development, renovation, rehabilitation or construction of facilities owned and used by such arts organizations.

The purpose of this hearing is to receive testimony from the government and the public on these bills. Persons who wish to present oral testimony at the hearing should provide their names, addresses, telephone numbers, and the name of the organization they represent (if any) to David L.
