Bill 15-314, introduced by Chairman Cropp at the request of the Mayor, would close a portion of Jewett Street, N.W., bounded by Connecticut Avenue, N.W., Klinge Road, N.W., and adjacent to Square 2214, in Ward 3. The applicant is the Klinge Corporation, which request the closing to allow for the creation of a tree buffer zone between the property owned by the National Park Service and the National Zoological Park of the Smithsonian Institution on the east of Jewett Street, and the proposed addition to the Kennedy-Warren Apartment on the west side of Jewett Street, which is owned by the Klinge Corporation. The portion of Jewett Street, N.W., to be closed has never been built or used as a public street.
