The purpose of the Public Oversight Roundtable is to receive a status report from the District of Columbia Board of Elections and Ethics on the District's Compliance with the Help America Vote Act and updates on the First in the Nation Primary. The federal Help America Vote Act of 2002 ("HAVA"), approved October 29, 2002, Pub. L. 105-252, was in response to the Presidential Election of 2000. The Act proposes to modernize voting systems nationally, enhance the integrity of voting procedures, guarantee ballot access for the disabled, and strengthen individual voting rights.

Legislation was introduced in Council Period XIV, amending Title 1 of the District of Columbia Official Code to change the dates for holding elections to allow the District of Columbia to hold the first Presidential Primary in the nation in 2004. The Board of Elections and Ethics will provide a status report to the Committee concerning

actions taken by the Board to prepare the District of Columbia government and its citizens for the first in the nation primary.
