PUBLIC HEARING ANNOUNCEMENT**

The DC Energy Office (DCEO) will hold a public hearing on its energy assistance and weatherization programs for FY 2004 in the DCEO Conference Room at 10:00 a.m. on Friday, August 22, 2003 at 2000 14th Street, NW, Suite 300 East, Washington, DC 20009. The programs provide energy assistance and energy efficiency services for eligible District of Columbia applicants under the Low Income Home Energy Assistance Program (LIHEAP) and the Weatherization Assistance Program (WAP).

Program activities are funded and authorized (pending federal approvals) under the U.S. Department of Health and Human Services Low Income Home Energy Assistance Act of 1981, Title XXVI of the Omnibus Budget Reconciliation Act of 1981, Public Law 97-35 and by the US Department of Energy as governed by Title IV, Part A, Energy Conservation Policy Act, P.L. 94-385, and as amended by the State Energy Efficiency Programs Improvement Act of 1990, P.L. 101-440 and by other applicable federal and District of Columbia laws and regulations.

Persons wishing to testify are asked to call the number below to have their names placed on the witness list no later than Tuesday, August 19, 2003. Individual statements at the hearing will be limited to five minutes. Written testimony must be received by the DCEO no later than Wednesday, August 27, 2003.

The state plans will not be mailed to requesters. Only one copy of each state plan will be provided per requestor. Copies of the state plan will be available for pick-up only, weekdays from 9:00 a.m. to 4:00 p.m. beginning Monday, July 21, 2003 at the DCEO.
