Councilmember Jack Evans, Chairman of the Committee on Finance and Revenue, announces a public hearing on bill 15-104, the "District of Columbia Neighborhood Economic Development and Investment Amendment Act of 2003". The hearing will be held on Monday, June 23, 2003 at 10:00 a.m. in room 412 of the John A. Wilson Building, 1350 Pennsylvania Avenue, N.W., Washington, D.C. 20004.

Bill 15-104, the "District of Columbia Neighborhood Economic Development and Investment Amendment Act of 2003" would establish a streamlined approval process for various economic assistance programs; improve the manner in which revenue bonds are issued, repeal the existing Tax Increment Financing Act and establish a more comprehensive and improved Act; establish economic development incentives in the form of payments in lieu of taxes and the formation of special assessment districts; and provide for the award of certain development and employment incentives to qualified businesses. This legislation was introduced on January 31, 2003 by Chairman Linda Cropp at the request of the Mayor.

The Committee invites the public to testify at the hearing.
