

Official Code § 1-204.22(2) (2001), and pursuant to section 204 of the Water and Sewer Authority Establishment and Department of Public Works Reorganization Act of 1996, effective April 18, 1996 (D.C. Law 11-111; D.C. Official Code § 34-2202.04), it is hereby **ORDERED** that:






SUBJECT: Appointment – Interim Chairperson, Public Service Commission of the District of Columbia
