## D.C. LAW 14-307

**"Fiscal Year 2003 Budget Support  
Amendment Act of 2002"**

Pursuant to Section 412 of the District of Columbia Home Rule Act, P.L. 93-198 (the Charter), the Council of the District of Columbia adopted Bill 14-892 on first and second readings October 1, 2002 and November 7, 2002, respectively. Following the signature of the Mayor on December 4, 2002, pursuant to Section 404(e) of the Charter, the bill became Act 14-543 and was published in the December 27, 2002 edition of the D.C. Register (Vol. 49, page 11664). Act 14-543 was transmitted to Congress on January 30, 2003 for a 60-day review, in accordance with Section 602(c)(2) of the Home Rule Act.

The Council of the District of Columbia hereby gives notice that the 60-day Congressional review period has ended, and Act 14-543 is now D.C. Law 14-307, effective June 5, 2003.

## D.C. LAW 14-308

**"Treatment Instead of Jail for Certain  
Non-Violent Drug Offenders Initiative of 2002"**

Pursuant to Amendment No. 1 of the District of Columbia Home Rule Act, P.L. 93-198 (the Charter), the electors of the District of Columbia voted on Initiative No. 62 on November 5, 2002, the Board of Elections and Ethics certified the results as 86,162 for the Initiative and 24,063 against the Initiative.

Following certification of the results, this initiative was assigned Act 14-545, published in the January 10, 2003 edition of the D.C. Register (Vol. 50, page 186). Act 14-545 was transmitted to Congress on January 30, 2003 for 60-day review, in accordance with Section 602(c)(2) of the Home Rule Act.

The Council of the District of Columbia hereby gives notice that the 60-day Congressional review period has ended, and Act 14-545 is now D.C. Law 14-308, effective, June 5, 2003.
