ERRATA

The District of Columbia Lottery and Charitable Games Control Board published a Notice of Final Rulemaking amending 30 DCMR, Chapter 9 "DESCRIPTION OF ON-LINE GAMES" and Chapter 99 "DEFINITIONS" in the D.C. Register at 50 DCR 1525, February 14, 2003. The notice erroneously states "928. AMEND CHAPTER 99, DEFINITIONS". The correct language is "**928-930 [RESERVED]**". This corrected language is immediately followed by:

AMEND CHAPTER 99, "DEFINITIONS"

Amend subsection 9900.1 by adding the following:

KENO Exchange Ticket - a terminal generated ticket to replace a consecutive KENO Ticket that is validated before the last game on the KENO Ticket.

KENO Game Play - the number or group of numbers that a player selects for each KENO drawing.

KENO Ticket - a terminal generated ticket for a KENO Game Play.

Spot - a set of numbers, from one (1) to ten (10), that a player may select for a KENO Game Play. Each set of numbers is a single Spot.

NOTICE OF FINAL RULEMAKING

TT00-5, IN THE MATTER OF BELL ATLANTIC-WASHINGTON, D.C.,
INC, COMPLIANCE WITH TITLE VI, DISTRICT OF COLUMBIA BUDGET
SUPPORT ACT, RENTAL OF PUBLIC STRUCTURE IN PUBLIC SPACE, D.C.

1. The Public Service Commission of the District of Columbia ("Commission") hereby gives notice pursuant to D.C. Code, 2001 Ed. § 2-505 of its final rulemaking action taken on April 30, 2003, in Order No. 12714, approving the tariff filing of Verizon Washington, DC Inc. (Verizon DC).¹

2. As explained in more detail in Order No. 12714, Verizon DC submitted a revised Right-of-Way Surcharge Tariff on June 21, 2000, proposing to collect the District's right-of-way fee from its customers. The Commission published a Notice of Proposed Rulemaking ("NOPR") on May 26, 2000, at 47 *D.C. Reg.* 4423-4424 (2000), advising the public of Verizon DC's proposal. In response to the NOPR, the Office of the People's Counsel and Verizon DC filed separate comments. After considering the comments of the parties, the Commission has made no change in Verizon DC's proposed tariff. Verizon DC's tariff shall become effective upon publication of this notice in the *D.C. Register*.
