


Council of the District of Columbia**Notice of Proposed Contract Disapproval Resolution**

The Council provided notice in the D.C. Register published on April 11, 2003 of its intention to consider the following resolution, PR 15-171, " Proposed Contract No. CAS 15-22 with Thompson, Cobb, Bazilio and Associates Disapproval Resolution of 2003", in less than 15 days.

The Council's 15 day review of the contract begins on Monday, April 14, 2003 and ends on Friday, May 2, 2003. The contract will be deemed approved on May 5, 2003 unless the Council adopts a resolution of approval or disapproval prior to that time.





A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

Councilmembers Jack Evans, Sharon Ambrose, Kathy Patterson, David A. Catania, and Carol Schwartz introduced the following resolution, which was referred to the Committee on _____.

To disapprove proposed Contract No. CAS 15-22 between the Office of Contracting and Procurement and Thompson, Cobb, Bazilio and Associates in the amount of \$10,937,118.02 for project management, privacy rule compliance, and related services to support the implementation of compliance requirements of the Health Insurance Portability and Accountability Act within various District agencies.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Proposed Contract No. CAS 15-22 with Thompson, Cobb, Bazilio and Associates Disapproval Resolution of 2003".

Sec. 2. (a) Pursuant to section 451 of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-204.51), and pursuant

to D.C. Official Code §2-301.05a, the Mayor transmitted proposed Contract No. CAS 15- 1
22 between the Office of Contracting and Procurement and Thompson, Cobb, Bazilio and 2
Associates in the amount of \$10,937,118.02 for project management, privacy rule 3
compliance, and related services to support the implementation of compliance 4
requirements of the Health Insurance Portability and Accountability Act within various 5
District agencies, to the Council for review and approval. 6

(b) The Council disapproves the contract. 7

Sec. 3. Fiscal impact statement. 8

The Council adopts the attached fiscal impact statement as the fiscal impact 9
statement required by section 602(c)(3) of the District of Columbia Home Rule Act, 10
approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(3)). 11

Sec. 4. The Secretary to the Council shall transmit a copy of this resolution to the 12
Mayor upon its adoption. 13

Sec. 5. This resolution shall take effect immediately. 14
