**LIST OF PERSONS REQUIRED TO FILE  
FINANCIAL DISCLOSURE STATEMENTS**

The Director of Campaign Finance herewith publishes a list of names of candidates, officers and employees required to file Financial Disclosure Statements, pursuant to the District of Columbia Campaign Finance Reform and Conflict of Interest Act of 1974, as amended, D.C. Official Code Section 1-1106.02 (2001 Edition). D.C. Official Code Section 1-1106.02 provides that during April of each year, the Director of Campaign Finance (Board of Elections and Ethics) shall publish, in the District of Columbia Register, a list of names of candidates, officers and employees required to file a Financial Disclosure Statement as of the last day of the preceding March. This listing complies with D.C. Official Code Section 1-1106.02.

**1. Filing Requirements**

On or before **May 15, 2003**, each person listed is required to file a Financial Disclosure Statement with the Director of Campaign Finance for calendar year 2002.\* In addition, each person listed is required to submit a Financial Disclosure Statement amendment within 30 days of any change in information in a previously filed statement, and to file a Financial Disclosure Statement, if such person ceases to serve prior to May 15<sup>th</sup> of any year, on their last day of office, or no later than 90 days after such date.

**2. Candidates for Public Office**

Each candidate for nomination for election or election to public office, at the time such person becomes a candidate, and does not occupy such office, is required to file a Financial Disclosure Statement within one month after becoming a candidate for such office (D.C. Official Code Section 1-1106.02).

**3. Elected Officials**

Each listed elected official is required to file a Financial Disclosure Statement on or before **May 15, 2003**. An elected official who is also a candidate for nomination for election or re-election, is not required to file more than one Financial Disclosure Statement.

The elected officials required to file a Financial Disclosure Statement are the Mayor, the Chairperson and each Member of the Council of the District of Columbia, the President and each Member of the District of Columbia Board of Education, and the D.C. Senators and Representative. (D.C. Official Code Section 1-1106.02).

**4. Agency Heads**

Each listed agency head is required to file a Financial Disclosure Statement by, or not later than, **May 15, 2003**. The term "agency head" means an individual appointed by the Mayor, who is the highest ranking executive official of either an agency under the direct administrative control of the Mayor, or an independent agency not under the direct administrative control of the Mayor [D.C. Official Code Sections 1-603.1 (13) and 17)].

**5. Members of Boards and Commissions**

Each member of a board or commission listed under D.C. Official Code Section 1-1106.02 (a) or created after April 23, 1980, and listed herein, who makes decisions in areas of contracting, procurement, administration of grants or subsidies, planning or developing policies, inspecting, licensing, regulating, auditing or acting in areas of responsibility involving any potential conflict of interest, is required to file a Financial Disclosure Statement by, or not later than, **May 15, 2003**.

**6. Management Supervisory, Legal and Excepted Service Employees Paid at a Rate of DS-13 (includes DS-12/7 or above or designated in Section 1-610.8)**

Each Management Supervisory Service, Legal and Excepted Service employee listed is required to file a Financial Disclosure Statement by, or not later than, **May 15, 2003**.

The term "employee" means an individual occupying a position in the District of Columbia government as provided for in D.C. Official Code Sections 1-601.1 *et seq.*, and Chapters 9, "Excepted Service", and 36 "Legal Service", of the District of Columbia Personnel Manual (27 DCR 4285; and 47 DCR 7371); and paid at a rate of DS-13 or above. D.C. Official Code, Section 1-1106.02 was amended recently by D.C. Law 14-213, (the "Technical Amendments Act of 2002" to include the filing of Financial Disclosure Statements by Management Supervisory Service (MSS) employees, paid at the rate of MS-13 or above.

**7. Financial Disclosure Statement**

Each candidate, officer, or employee required to file a Financial Disclosure Statement, who has served in more than one position required to file under D.C. Official Code Section 1-1106.02 (a), (i.e., a member of more than one board, or a government employee who also serves on a board or commission) may use one Financial Disclosure Statement form in lieu of multiple filings to disclose these positions. However, each position must be clearly listed on page one of the Financial Disclosure Statement. An attachment or letter of explanation listing multiple positions and each board or commission on which the candidate, officer or employee is a member must be submitted to comply with this disclosure requirement.

**8. Request for Filing Extension**

Any person who requires an extension of time to file a Financial Disclosure Statement may do so by submitting a written request to the Director of Campaign Finance, on or before **May 15, 2003**, specifying the reason(s) for the extension and the date by which the statement will be filed. The Director of Campaign Finance may grant an extension for a period not to exceed 30 days.

**9. Request for Exemption**

Any person who requests an exemption from filing a Financial Disclosure Statement may do so by writing the Director of Campaign Finance, on or before **May 15, 2003**, specifying the why an exemption should be granted. The Director of Campaign Finance may, on a case-by-case basis, provide for certain justified exemptions from these disclosure requirements, which are deemed to be de minimus.

**10. Forms Distribution**

The Office of Campaign Finance mails a Financial Disclosure Statement form to each individual required to file. Additional forms and information can be obtained from the Office of Campaign Finance, by telephone (202) 671-0547 or by visiting the Agency at 2000 14<sup>th</sup> Street, NW, Suite 420, Washington, DC 20009. Copies of the Financial Disclosure regulations, 3 DCMR Sections 3200 et seq. June 1998, as amended, may be obtained at the Office of Campaign Finance, or downloaded from the OCF Web Site at [www.dcofc.org](http://www.dcofc.org).

**12. When to File**

**May 15, 2003** represents the final day for the timely filing of a Financial Disclosure Statement, not the only day the statement can be filed. Financial Disclosure Statements covering the 12 months of 2002 will be accepted by this Agency anytime between **January 1, 2003 and May 15, 2003**. Statements are considered **timely** filed (whether hand delivered or mailed), if received by 5:30 p.m. on **May 15, 2003**. Financial Disclosure Statements maybe submitted electronically at [www.ocf.dc.gov](http://www.ocf.dc.gov) and a printed and signed copy of the FDS must be mailed or delivered to the Office of Campaign Finance. An electronically submitted statement is considered timely filed by midnight of the prescribed filing date.

13. **Corrections**

Any corrections to the information published herein, should be directed to the Office of Campaign Finance. Any candidate, officer, or employee who is required to file a Financial Disclosure Statement under D.C. Official Code Section 1-1106.02 (a), but not listed, should immediately contact the Director of Campaign Finance.

14. **Penalties for Violation of Financial Disclosure Filing Requirements**

A civil penalty under D.C. Official Code Section 1-1103.05 (b) may be imposed ministerially, by the Director of Campaign Finance, upon any person required to file a Financial Disclosure Statement who commits any of the following violations:

- A. Failure to file a Financial Disclosure Statement;
- B. Failure to timely file a Financial Disclosure Statement; and
- C. Failure to file a complete Financial Disclosure Statement.

A person who knowingly file a false or misleading Financial Disclosure Statement is subject to the penalties under D.C. Code Section 1-1107.01.
