Bill 17-907 would exempt a new, full service grocery store or substantially renovated full-service grocery store in ANC 4C07 from the current moratorium on applying for Class B alcoholic beverage licenses.

Bill 17-941 would prohibit the sales of single containers of beer, malt liquor, or ale, by off-premises retailers located in a targeted area of Ward 4.
