NOTICE OF EVIDENTIARY HEARING

FORMAL CASE NO. 1040, IN THE MATTER OF THE INVESTIGATION INTO VERIZON WASHINGTON, DC INC.'S UNIVERSAL EMERGENCY NUMBER 911 SERVICES RATES IN THE DISTRICT OF COLUMBIA

1. The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice, pursuant to D.C. Code Section 34-909,<sup>1</sup> of the hearing scheduled in this proceeding on **November 5 and 6, 2008**. The hearing will begin each day at **10:00 a.m.** in the Commission’s Hearing Room, 1333 H Street, N.W., 7<sup>th</sup> Floor, East Tower, Washington, DC.

2. This matter is a formal rate proceeding before the Commission initiated to determine a reasonable rate for the E911 services Verizon Washington, DC Inc. (“Verizon”) provides to the District of Columbia Government under its Universal Emergency Number 911 Services Tariff.<sup>2</sup> A procedural schedule was adopted<sup>3</sup> and the schedule, along with all other documents in this case, may be viewed at the Office of the Commission Secretary between the hours of 9:00 a.m. and 5:30 p.m., Monday through Friday.
