1. The Public Service Commission of the District of Columbia ("Commission") pursuant to its authority under D.C. Official Code § 2-505, hereby gives notice of its final rulemaking action in Order No. 15080 (October 1, 2008), approving the tariff application of Verizon Washington, DC Inc. ("Verizon DC") to amend the following tariff pages:

GENERAL SERVICES TARIFF, P.S.C.-D.C.-NO. 203 Section 4, 4th Revised Page 6

- 2. In its application, Verizon DC seeks to increase the monthly recurring rates for two of its services: Nonpublished Listing Service from \$1.17 to \$1.34, an increase of 14.5%; and Nonlisted Service from \$0.62 to \$0.71, an increase of 14.5%. Verizon DC asserts that the proposed revisions are filed pursuant to \$3(a) of Price Cap Plan 2004 ("Plan"). In addition, Verizon DC states that the services are classified as Discretionary Services under the Plan and that rate increases for these services are therefore limited to 15% annually.
- 3. The Commission issued a Notice of Proposed Rulemaking ("NOPR"), which was published in the *D.C. Register* on August 1, 2008, inviting public comment on the proposed tariff amendment. No comments were filed. Subsequently, the Commission approved Verizon DC's Application in Order No. 15080, finding that the tariff revisions were consistent with the requirements of Section 3(a) of Price Cap Plan 2004. The tariff revisions will become effective upon the date of publication of this
