Councilmember Barry filed on December 23, 2008, PR 17-1286 the "Reprogramming No. 17-178 Disapproval Resolution of 2008" to disapprove Reprogramming 17-178. The request to reprogram \$25,307,576 in FY 2009 Local funds budget authority within the Department of Mental Health (DMH) was filed in the Chairman's Office on December 11, 2008.
