DISTRICT PERSONNEL MANUAL (E-DPM)**

The purpose of this notice is to inform the general public that as part of its paperless initiatives, the D.C. Department of Human Resources (DCHR) has officially replaced the four-volume (4-volume) “District Personnel Manual” or “DPM” with the “Electronic District Personnel Manual” or “E-DPM.”

BACKGROUND – DISTRICT PERSONNEL MANUAL

A Notice was published in the *D.C. Register* on February 14, 1986 (33 DCR 1008) announcing the implementation of the DPM effective January 31, 1986. The DPM contained procedures implementing the provisions of the District of Columbia Government Comprehensive Merit Personnel Act of 1978 (“CMPA”), effective March 3, 1979 (D.C. Official § 1-601.01 *et seq.*); and the D.C. personnel regulations (Title 6 of the District of Columbia Municipal Regulations (DCMR)). It also provided (in Part I of each chapter) the rules.

CONTENT OF THE E-DISTRICT PERSONNEL MANUAL

The E-DPM also contains the rules implementing the provisions of the CMPA and Title 6 of the DCMR. In addition to the rules, the E-DPM contains operating guidance and procedures applicable to agencies under the personnel authority of the Mayor (“subordinate agencies”).

FY 2009 Equipment Assistance Grants for School Food Authorities

Public Law 111-5, the American Recovery and Reinvestment Act of 2009 (ARRA), was signed into law by President Obama on February 17, 2009. Through the ARRA, the District of Columbia has been awarded a one-time appropriation of \$215,765 for equipment assistance grants for School Food Authorities (SFAs) participating in the National School Lunch Program (NSLP).

Due to this opportunity, the Office of the State Superintendent of Education, Wellness and Nutrition Services Division, announces an opportunity for all schools participating in NSLP, to apply for grant funds through a competitive process.

For more specific information, applicants should review the eligibility requirements in the Request for Applications (RFA). The Request for Application (RFA) will be made available for review and application the week of April 27, 2009 on our website, www.osse.dc.gov.

The primary effect of the funds is to improve the infrastructure of NSLP, however it is important to note that authority and funds for the grants was provided in the overall context of stimulating the economy. With this in mind, the application period and subsequent notification of awards will be completed by June 1, 2009 in order to facilitate schools obligating and/or spending the funds before the end of the fiscal year.
