Mayor's Order 2009-119  
June 25, 2009

**SUBJECT:** Establishment – Mayor's Inter-Agency Task Force on Coordination and Management of the Supports and Services Delivery System for Persons with Intellectual and Developmental Disabilities

**ORIGINATING AGENCY:** Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(2) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22(2) (2008 Supp.), it is hereby **ORDERED** that:

**I.     ESTABLISHMENT**

There is established in the Executive Branch of the government of the District of Columbia a Mayor's Inter-Agency Task Force on Coordination and Management of the Supports and Services Delivery System for Persons with Intellectual and Developmental Disabilities ("Task Force").

**II.    BACKGROUND AND PURPOSE**

In an Order dated January 21, 2004, the Court in *Evans v. Williams*, Civil Action No. 76-293 (ESH), pending in the United States District Court for the District of Columbia, required in pertinent part that the Mayor assign a senior official to be responsible for the inter-agency coordination and management of the District government's supports and services to persons with intellectual and developmental disabilities. Mayor's Order 2006-101, dated July 26, 2006, is no longer a viable basis for coordinated inter-agency efforts, principally due to the subsequent restructuring of services delivery, including the establishment of the Department on Disability Services ("DDS"). The Court and, more importantly, the consumer population, therefore need assurance of the District's resolve to continue to improve its services delivery system and inter-agency coordination.

The purpose of the Task Force shall be to oversee and coordinate those steps deemed necessary and appropriate with respect to improving the District government's supports and services delivery system for persons with intellectual and developmental disabilities.

### III. FUNCTIONS

The functions of the Task Force shall include:

- a. Advising the Mayor and the Director of DDS on all matters related to the District government's activities with respect to District-wide efforts to improve the supports and services delivery system for persons with intellectual and developmental disabilities;
- b. Reviewing the efforts of all District government agencies whose activities relate to District-wide efforts to improve the supports and services delivery system for persons with intellectual and developmental disabilities, so as to identify any gaps in necessary and appropriate efforts related to District-wide efforts to improve the supports and services delivery system for persons with intellectual and developmental disabilities;
- c. Developing priorities and best practices to meet any gaps in such efforts, to foster continued activities and improvements, and to advance the end of court supervision;
- d. Assisting in the coordination of efforts and communications between all agencies whose activities relate to District-wide efforts to improve the supports and services delivery system for persons with intellectual and developmental disabilities; and
- e. Undertaking any other functions as the Mayor or the DDS Deputy Director may direct consistent with this Order.

### IV. COMPOSITION

The Task Force shall be comprised of the following members:

- a. Deputy Director, Department on Disability Services/Developmental Disabilities Administration, who shall serve as the Task Force Chairperson;
- b. Deputy Director, Department of Health Care Finance;
- c. Associate Director, Department of Health Care Finance/Office of Chronic & Long-Term Care;
- d. Senior Deputy Director, Department of Health/Health Regulation and Licensing Administration;
- e. Health and Human Services Program Manager, Office of the City Administrator; and

f. Designee from the Office of the Attorney General.

V. MEETINGS


The Task Force shall meet on a regular schedule at least once each month and at such other times as may be deemed necessary by the Chairperson. Non-attendance of any member at a regular meeting, other than for emergency reasons, shall be excused in advance by the Chairperson. Participation in any meeting may be by telephone. A quorum for purposes of conducting a meeting shall be the Chairperson and at least two other Task Force members.

VI. RESCISSION

Mayor's Order 2006-101, dated July 26, 2006, is rescinded.

**SUBJECT:** Delegation of Authority Pursuant to D.C. Law 5-48, the "Health-Care and Community Residence Licensure Act of 1983"


**ORIGINATING AGENCY:** Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by sections 422(6) and (11) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code §§ 1-204.22(6) and (11) and 1-204.49(2) (2008 Supp.), and Section 2(b) of the Health-Care and Community Residence Facility, Hospice and Home Care Licensure Act of 1983 (the Act), effective February 24, 1984, D.C. Law 5-48, D.C. Official Code § 44-501 *et seq.* (2005 Repl.), it is hereby **ORDERED** that:

1. The Director of the Department on Disability Services (DDS) is hereby delegated the Mayor's authority under subsection 2(b) of the Act to define, with respect to services and supports under the District of Columbia Medicaid Home and Community-Based Services Waiver to Persons with Intellectual and Developmental Disabilities, variant types of facilities and agencies reasonably classified within the broader categories defined in subsection 2(a) of the Act.
2. The Director of DDS is delegated the Mayor's authority to issue rules pursuant to subsection 2(b) of the Act concerning the subtypes established in accordance with paragraph (1) of this Order. The Director is also delegated the Mayor's authority under subsection 2(b) to make the final determination as to whether a particular facility or agency falls within a category defined in subsection 2(a) of the Act or a subtype that DDS has defined pursuant to subsection 2(b).
3. This Order supersedes Mayor's Order 84-105, and any other prior Mayor's Order, to the extent that any provision of the prior order is inconsistent with this Order.
4. **EFFECTIVE DATE:** This Order shall be effective immediately.

**SUBJECT:** Designation of the Office of Partnerships and Grant Services as the "Authorized Entity" to Apply for and Administer a Grant Under the American Recovery and Reinvestment Act of 2009 to Build Government Capacity to Assist Faith-Based and Community Organizations

**ORIGINATING AGENCY:** Office of the Mayor, Office of Partnerships and Grant Services

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(4) and (11) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22(4) and (11)(2008 Supp.), it is hereby **ORDERED** that:

**I. BACKGROUND AND PURPOSE:**

- A. On February 17, 2009, President Barack Obama signed the American Recovery and Reinvestment Act of 2009 ("ARRA"), Pub. L. 111-5, into law. The ARRA presents an unprecedented opportunity to preserve and create jobs, to invest in infrastructure, to develop energy efficiency and new technology initiatives, to provide assistance to the unemployed, to train and educate the workforce, and to stimulate future economic growth.
- B. The key to a strong and growing District of Columbia ("District") economy is connecting people to job openings and connecting employers to a skilled workforce. ARRA funding will support initiatives to build a strong workforce and a world-class workforce development system that connects people to the industries with job openings and employers to skilled workers.
- C. Now, a funding opportunity is being made available under Title VIII of the ARRA. This opportunity has been designated as CFDA # 93.711 in the Catalog of Federal Domestic Assistance.
- D. Specifically, the Administration for Children and Families ("ACF"), Office of Community Services, of the federal Department of Health and Human Services is soliciting applications to award 48 grants in amounts of up to \$250,000 to State, Local and Tribal governments. The grants will be made to government offices responsible for outreach to faith-based and community organizations to build the capacity of these offices to provide training and technical assistance to their faith-based and community partners.

This training and technical assistance will assist the organizations in addressing the economic recovery issues present in their communities, including helping low-income individuals secure and retain employment, earn higher wages, obtain better quality jobs and gain greater access to state and federal benefits and tax credits.

- E. To qualify for funding, the District must designate an "Authorized Entity" to apply for and administer the grant.

**II. APPOINTMENT OF THE OFFICE OF PARTNERSHIPS AND GRANT SERVICES ("OPGS") AS THE "AUTHORIZED ENTITY" UNDER THE GRANT**

OPGS is hereby appointed the "Authorized Entity" (as that term is defined in the referenced grant application for CFDA #93.711) for the District for the purpose of applying for and administering the grant.

**III. RESPONSIBILITIES OF OPGS**

- A. OPGS shall serve as the coordinating office for other District agencies and instrumentalities to access information and services with regard to CFDA 93.711. In that connection, OPGS shall be responsible for, among other things, 1) drafting, obtaining approval and implementing the "Outreach, Training and Technical Assistance Capacity-Building Needs Assessment and Workplan" required by the grant; 2) conducting programmatic and financial oversight of the District's capacity-building program under the grant award; 3) participating in national evaluation studies where necessary or desirable, and 4) sending two key staff persons to an annual grantee conference in Washington, D.C. as requested by ACF.
- B. As the Authorized Entity, OPGS shall provide the necessary support, access, authority, and oversight required of the District with regard to the programmatic, financial and reporting obligations associated with the grant



**SUBJECT:** Posting of Job Opportunities from the American Recovery and Reinvestment Act of 2009 on the District of Columbia Department of Employment Services Website

**ORIGINATING AGENCY:** Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(4) and (11) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22(4) and (11) (2008 Supp.), it is hereby **ORDERED** that:

**I. BACKGROUND AND PURPOSE:**

- A. On February 17, 2009, President Barack Obama signed the "American Recovery and Reinvestment Act of 2009," effective February 17, 2009, 123 Stat. 115, Pub. L. 111-5, ("ARRA"), into law. The ARRA presents an unprecedented opportunity to preserve and create jobs, to invest in infrastructure, to develop energy efficiency and new technology initiatives, to provide assistance to the unemployed, to train and educate the workforce, and to stimulate future economic growth.
- B. The key to a strong and growing District of Columbia ("District") economy is connecting people to job openings and connecting employers to a skilled workforce. ARRA funding will support initiatives to build a strong workforce and a world-class workforce development system that connects people to the industries with job openings and employers to skilled workers.
- C. The District has highly motivated workers who desire meaningful employment that allows them to support themselves and their families. Connecting job seekers and employers will create new economic opportunities for the District's workers and employers.
- D. The District affirms its commitment to the creation of new jobs and training opportunities made possible by ARRA investments by requiring the posting of these opportunities on the Department of Employment Services ("DOES") website.

**II. AGENCY REQUIREMENTS**

- A All District government agencies subordinate to the Mayor shall include in all contracts or agreements funded, in whole or in part, by the ARRA ("ARRA-funded contracts"), for which the invitations for bids or other solicitations for bids are published on or after the issuance of this Order, a clause requiring




contractors and subcontractors employing workers in the District to post job openings created by ARRA-funded contracts on the District's DOES on-line One-Stop Career Center system, [www.dcnetworks.org](http://www.dcnetworks.org).

- B. All District government agencies managing local projects funded by the ARRA, for which contracts were entered into before the issuance of this Order, shall, insofar as this is possible or appropriate, direct contractors and sub-contractors who employ workers in the District to post job openings created by ARRA-funded local projects on the DOES on-line One-Stop Career Center system, [www.dcnetworks.org](http://www.dcnetworks.org). Additionally, agencies shall, insofar as this is possible or appropriate, take all actions necessary to effectuate the intent of this paragraph, including, but not limited to, entering into Memorandums of Understanding or amending existing agreements.
- C. Independent government agencies (e.g., DCHA, WASA) and their subunits that manage local projects funded by the ARRA are encouraged to require contractors and subcontractors who employ workers in the District to post job openings created by ARRA-funded local projects on the DOES on-line One-Stop Career Center system, [www.dcnetworks.org](http://www.dcnetworks.org).
- D. Posting is not required where a contractor or subcontractor of an ARRA-funded contract intends to fill the job opening created by ARRA funding with a present employee, a laid-off former employee, or a job candidate from a previous recruitment, or where an exception has been granted by the Mayor or his designee.
- E. The posting of ARRA-funded job openings through the DOES One-Stop Career Center system, [www.dcnetworks.org](http://www.dcnetworks.org), as required by this Order, shall not be the exclusive means to hire workers for ARRA funded jobs. Employers are encouraged to also use the District's labor exchange and One Stop Career Center services to hold recruitment and outreach activities and to use employer-sponsored job advertising and recruitment methods.
