Official Code § 1-204.22(6) (2001), the Emergency and Non-emergency Number Telephone Calling Systems Fund Act of 2000, effective October 19, 2000 (D.C. Law 13-172; D.C. Official Code § 34-1801 *et seq.*), and section 3208 of the Office of Unified Communications Establishment Act of 2004, effective December 7, 2004 (D.C. Law 15-205; D.C. Official Code § 1-327.57), it is hereby **ORDERED** that:

1. The Director of the Office of Unified Communications is delegated the authority to take any and all actions authorized to be performed by the Mayor pursuant to the Emergency and Non-emergency Number Telephone Calling Systems Fund Act of 2000 (Fund Act). This authority includes, but is not limited to, the Mayor's authority to receive any payment of tax imposed by the Fund Act, and the authority to take all necessary and proper actions to assure the amount received is the full amount due.
2. The Director of the Office of Unified Communications is delegated the Mayor's rulemaking authority pursuant to section 3208 of the Office of Unified Communications Establishment Act of 2004.
3. The authority delegated herein to the Director of the Office of Unified Communications may be further delegated by the Director to subordinates under his or her direction.
4. This Order supersedes Mayor's Order 2001-40, dated March 22, 2001, and all previous Mayor's Orders to the extent of any inconsistency herein.

Official Code §§ 8-1815 and 8-2301 *et seq.* ("Act"), it is hereby **ORDERED** that the Director of the Department of Health, is delegated the authority vested in the Mayor to:

1. Establish licensing requirements for commercial animal breeders including licensing fees, standards of care and management, and facility inspection requirements pursuant to section 201 of the Act.
2. Issue guard dog identification tags pursuant to section 402 of the Act.
3. Issue rules to implement Title IV of the Act pursuant to section 409 and issue rules to implement Titles II, III, and V pursuant to section 701.
4. Enforce violations of the Act pursuant to section 408.
5. Establish an emergency preparedness plan for the protection, sheltering, and evacuation of domestic animals during and following a major disaster or emergency pursuant to section 601.
6. The Director may further delegate this authority to a subordinate within the Department of Health.
7. **EFFECTIVE DATE:** This order shall become effective *nunc pro tunc* from December 5, 2008.







ORIGINATING AGENCY: Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(6) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22(6) (2008 Supp.) and the Emergency Medical Services Act of 2008, effective March 25, 2009, D.C. Law 17-357, D.C. Official Code §§ 7-2341.01 *et seq.* (hereinafter the "Act"), it is hereby **ORDERED** that:

1. The Director of the Department of Health is delegated the authority vested in the Mayor to:
 - A. Establish licensing and certification requirements, and issue licenses and certifications, pursuant to Sections 4, 5, 6, 7, 8, 9, 11, 13, and 15 of the Act.
 - B. Issue rules to implement the Act, pursuant to Sections 24 and 10(e) of the Act.
 - C. Conduct inspections, evaluations, and investigations pursuant to Section 14 of the Act.
 - D. Enforce violations of the Act, pursuant to Sections 16, 17, 18, and 25(c) of the Act.
 - E. Establish and maintain a trauma care system pursuant to Section 20 of the Act.
 - F. Establish a program of emergency medical services for children pursuant to Section 22 of the Act.
2. The Director of the Department of Health is authorized to make sub-delegations as necessary to carry out the provisions of the Act.
3. **EFFECTIVE DATE:** This Order shall become effective immediately.
