SUBJECT: Delegation of Authority to the Deputy Mayor for Planning and Economic Development – Authority to Issue a Certification Letter Stating that the 4100 Georgia Avenue Project is Eligible for a Property Tax Abatement


ORIGINATING AGENCY: Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(6) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22(6) (2009 Supp.), and the Square 2910 Residential Development Stimulus Act of 2006, approved December 19, 2006 (D.C. Law 16-226; D.C. Official Code § 47-857.07) (the "Act") it is hereby **ORDERED** that:

1. The Deputy Mayor for Planning and Economic Development ("Deputy Mayor") is delegated the Mayor's authority to issue to the 4100 Georgia Avenue Developer a certification letter stating that the 4100 Georgia Avenue Project is eligible for the abatement authorized in the Act, and that the Mayor has reserved the abatement for the 4100 Georgia Avenue Project in the allocated amount.
2. The Deputy Mayor is delegated the Mayor's authority to send a copy of the certification letter to the Director of the Real Property Tax Administration of the Office of Tax and Revenue.
3. The terms "4100 Georgia Avenue Project" and "4100 Georgia Avenue Developer" shall have the same meaning as set forth in the Act.
4. **EFFECTIVE DATE:** This Order shall become effective immediately.
