SUBJECT: Delegation of Rulemaking Authority to the Director of the Child and Family Services Agency under the Newborn Safe Haven Temporary Act of 2009


ORIGINATING AGENCY: Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(6) and (11) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22(6) and (11) (2008 Supp.), and pursuant to section 8 of the Newborn Safe Haven Temporary Act of 2009 ("Act"), effective July 18, 2009, D.C. Law 18-29, 56 DCR 4258, and any similar successor legislation, it is hereby **ORDERED** that:

1. The Director, Child and Family Services Agency, is delegated authority under the Act and any substantially similar successor legislation to promulgate rules.
2. The authority delegated herein to the Director may be further delegated by the Director to subordinates under his or her jurisdiction.
3. **EFFECTIVE DATE:** This Order shall become effective immediately.

SUBJECT: Appointment – Board for the Condemnation of Insanitary Buildings


ORIGINATING AGENCY: Office of the Mayor

Immunization of School Students Act of 1979


ORIGINATING AGENCY: Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(6) and (11) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22(6) and (11) (2009 Supp.), and the Immunization of School Students Act of 1979, effective September 28, 1979 (D.C. Law 3-20; D.C. Official Code § 38-501 *et seq.*) (2001) ("Act"), it is hereby **ORDERED** that:

1. The Director of the Department of Health ("Director") is delegated the authority vested in the Mayor under the Act.
2. The Director may further delegate all or a part of his or her authority under this Order to subordinates under his or her jurisdiction
3. Mayor's Order 2006-117, dated September 5, 2006, is hereby rescinded.
4. This Order supersedes all previous Mayor's Orders to the extent of any inconsistency therein.
5. **EFFECTIVE DATE:** This Order shall become effective immediately.
