

SUBJECT: Delegation of Authority to the Department of Parks and Recreation to Enter into an Agreement and Make Payments

ORIGINATING AGENCY: Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(2) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22(2) (2009 Supp.), and pursuant to section 3 of the Boys and Girls Clubs of Greater Washington Property Acquisition Temporary Act of 2009 (Act), effective October 3, 2009, D.C. Law 18-58, 56 DCR 5857, it is hereby **ORDERED** that:

1. The Director of the Department of Parks and Recreation ("Director") is delegated the authority vested in the Mayor, to enter into an agreement with the Boys and Girls Clubs of Greater Washington (BGCGW) for operations and programming at the Mary and Daniel Loughran Clubhouse #10, Frank R. Jelleff Branch, Hopkins Branch, Eastern Branch, and Richard England Clubhouse #14; to make payments to BGCGW to assist with making its lease payments at TheARC, 1901 Mississippi Avenue SE; and to reimburse BGCGW for expenses associated with office renovations and other costs related to BGCGW's relocation from Silver Spring Maryland to Richard England Clubhouse #14, 4103 Benning Road, NE, Washington, DC as set forth in the Act.
2. The authority delegated herein to the Director may be further delegated to subordinates under the jurisdiction of the Director.
3. This Order supersedes any prior Mayor's Order to the extent of any inconsistency therein.
4. **EFFECTIVE DATE:** This Order shall become effective immediately.




