SUBJECT: Appointment – Deputy Mayor for Planning and Economic Development


ORIGINATING AGENCY: Office of the Mayor





By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(6) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22(6) (2009 Supp.), and section 7102 of the Real Property Tax Reform Classification Emergency Amendment Act of 2009 ("Act"), effective October 15, 2009, D.C. Act 18-207, 56 DCR 8228, or any substantially identical emergency, temporary, or permanent legislation, it is hereby **ORDERED** that:

1. The Director, Department of Consumer and Regulatory Affairs is delegated the Mayor's authority under section 7102 of the Act to determine blighted properties.

SUBJECT: Delegation of Authority under the Financial Incentives for Motion Picture and Television Productions Emergency Amendment Act of 2009, effective October 15, 2009 (D.C. Act 18-207; 56 DCR 8277)

ORIGINATING AGENCY: Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(6) of the District of Columbia Home Rule Act, as amended, (87 Stat. 790; Pub. L. No. 93-198, D.C. Official Code § 1-204.22(6) (2009 Supp.)), and pursuant to section 2d of the Financial Incentives for Motion Picture and Television Productions Emergency Amendment Act of 2009, effective October 15, 2009 (D.C. Act 18-207; 56 DCR 8277) (hereinafter cited as the "Productions Incentives Act"), it is hereby **ORDERED** that:

1. The Director of the Office of Motion Picture and Television Development for the District of Columbia is delegated the authority vested in the Mayor pursuant to the Productions Incentives Act, to periodically revise by rulemaking the schedule of fees for motion picture and television production permits.
2. **EFFECTIVE DATE:** This Order shall become effective *nunc pro tunc* to October 15, 2009.
