The Director of the Department of Youth Rehabilitation Services ("Department") shall provide notice to the Chief of the Metropolitan Police Department of any assignment or placement of respondents, committed to the Department pursuant to section 16-2320(c)(2), in any Department facility, congregate care facility, or family or family surrogate placement. This notification requirement shall be limited to respondents who have been adjudicated of: (i) a crime of violence (as defined in section 23-1331(4)) and (ii) offenses involving a firearm (as defined in section 7-2501.01). Such notice shall be given as soon as practicable prior to the assignment or placement.
