
**SUBJECT:** Appointment – District of Columbia Small and Local Business Opportunity Commission

**SUBJECT:** Reappointment and Appointments – District of Columbia Small and Local Business Opportunity Commission


**ORIGINATING AGENCY:** Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422(2) of the District of Columbia Home Rule Act, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22(2) (2001), and in accordance with section 2321 of the Small, Local, and Disadvantaged Business Enterprise Development Assistance Act of 2005, effective October 20, 2005 (D.C. Law 16-33; D.C. Official Code § 2-218.21), it is hereby **ORDERED** that:

1. **ALBERTO GOMEZ** was nominated by the Mayor on March 23, 2009 and, following a forty-five day period of review by the Council of the District of Columbia, this nomination was deemed approved on June 30, 2009 for reappointment as a member of the District of Columbia Small and Local Business Opportunity Commission (hereinafter referred to as “Commission”) for a term to end March 28, 2011.
2. **ALBERTO GOMEZ** is appointed Chairperson of the Commission and shall serve in that capacity at the pleasure of the Mayor.
3. **KRISTEN BARDEN** was nominated by the Mayor on April 6, 2009 and, following a forty-five day period of review by the Council of the District of Columbia, this nomination was deemed approved on June 30, 2009 for appointment as a member of the Commission, replacing Darrin Glymph, whose term expired March 28, 2008, for a term to end March 28, 2010.
4. **LATRICE STRADER** was nominated by the Mayor on April 6, 2009 and, following a forty-five day period of review by the Council of the District of Columbia, this nomination was deemed approved on June 30, 2009 for appointment as a member of the Commission, replacing Danita Doleman, whose term expired March 28, 2008, for a term to end March 28, 2010.
5. **LLOYD HENRY** was nominated by the Mayor on April 6, 2009 and, following a forty-five day period of review by the Council of the District of Columbia, this nomination was deemed approved on June 30, 2009 for appointment as a member of the Commission,

replacing Calvin Nophlin, whose term expired March 28, 2009, for a term to end March 28, 2011.

6. **EFFECTIVE DATE:** This Order shall be effective *nunc pro tunc* to July 16, 2009.
