It will be conducted in accordance with the Review Board's Rules of Procedure (10A DCMR 2). A copy of the rules can be obtained from the Historic Preservation Office at 1100 4th Street, SW, Suite E650, Washington, DC 20024, or by phone at (202) 442-8800, and they are included in the preservation regulations which can be found on the Historic Preservation Office website.

The Board's hearing is open to all interested parties or persons. Public and governmental agencies, Advisory Neighborhood Commissions, property owners, and interested organizations or individuals are invited to testify before the Board. Written testimony may also be submitted prior to the hearing. All submissions should be sent to the address above.

For each property, a copy of the historic landmark application is currently on file and available for inspection by the public at the Historic Preservation Office. A copy of the staff report and recommendation will be available at the office five days prior to the hearing. The office also provides information on the D.C. Inventory of Historic Sites, the National Register of Historic Places, and Federal tax provisions affecting historic property.

If the Historic Preservation Review Board designates the property, it will be included in the D.C. Inventory of Historic Sites, and will be protected by the D.C. Historic Landmark and Historic District Protection Act of 1978. The Review Board will simultaneously consider the nomination

of the property to the National Register of Historic Places. The National Register is the Federal government's official list of prehistoric and historic properties worthy of preservation. Listing in the National Register provides recognition and assists in preserving our nation's heritage. Listing provides recognition of the historic importance of properties and assures review of Federal undertakings that might affect the character of such properties. If a property is listed in the Register, certain Federal rehabilitation tax credits for rehabilitation and other provisions may apply. Public visitation rights are not required of owners. The results of listing in the National Register are as follows:

Consideration in Planning for Federal, Federally Licensed, and Federally Assisted Projects: Section 106 of the National Historic Preservation Act of 1966 requires that Federal agencies allow the Advisory Council on Historic Preservation an opportunity to comment on all projects affecting historic properties listed in the National Register. For further information, please refer to 36 CFR 800.

Eligibility for Federal Tax Provisions: If a property is listed in the National Register, certain Federal tax provisions may apply. The Tax Reform Act of 1986 (which revised the historic preservation tax incentives authorized by Congress in the Tax Reform Act of 1976, the Revenue Act of 1978, the Tax Treatment Extension Act of 1980, the Economic Recovery Tax Act of 1981, and the Tax Reform Act of 1984) provides, as of January 1, 1987, for a 20% investment tax credit with a full adjustment to basis for rehabilitating historic commercial, industrial, and rental residential buildings. The former 15% and 20% Investment Tax Credits (ITCs) for rehabilitation of older commercial buildings are combined into a single 10% ITC for commercial and industrial buildings built before 1936. The Tax Treatment Extension Act of 1980 provides Federal tax deductions for charitable contributions for conservation purposes of partial interests in historically important land areas or structures. Whether these provisions are advantageous to a property owner is dependent upon the particular circumstances of the property and the owner. Because the tax aspects outlined above are complex, individuals should consult legal counsel or the appropriate local Internal Revenue Service office for assistance in determining the tax consequences of the above provisions. For further information on certification requirements, please refer to 36 CFR 67.

Qualification for Federal Grants for Historic Preservation When Funds Are Available: The National Historic Preservation Act of 1966, as amended, authorizes the Secretary of the Interior to grant matching funds to the States (and the District of Columbia) for, among other things, the preservation and protection of properties listed in the National Register.

Owners of private properties nominated to the National Register have an opportunity to concur with or object to listing in accord with the National Historic Preservation Act and 36 CFR 60. Any owner or partial owner of private property who chooses to object to listing must submit to the State Historic Preservation Officer a notarized statement certifying that the party is the sole or partial owner of the private property, and objects to the listing. Each owner or partial owner of private property has one vote regardless of the portion of the property that the party owns. If a majority of private property owners object, a property will not be listed. However, the State Historic Preservation Officer shall submit the nomination to the Keeper of the National Register of Historic Places for a determination of eligibility for listing in the National Register. If the property is then determined eligible for listing, although not formally listed, Federal agencies

will be required to allow the Advisory Council on Historic Preservation an opportunity to comment before the agency may fund, license, or assist a project which will affect the property. If an owner chooses to object to the listing of the property, the notarized objection must be submitted to the above address by the date of the Review Board meeting.

SUMMARY: The DC Office of Planning (“DCOP”) has published for public review and comment a draft Mt. Pleasant Street Revitalization Strategy Plan (“Draft Plan”) presents an analysis and corresponding recommendations on revitalization opportunities, and community development issues within the Mt. Pleasant Street commercial district. DCOP emphasizes that the findings, conclusions and revitalization scenarios in the draft Mount Pleasant Street Revitalization Strategy Plan are preliminary. DCOP is providing a 30-day public comment period on the draft Mount Pleasant Street Revitalization Strategy Plan. Comments must be postmarked by the close of the comment period. Information on how to submit comments is set forth below.

The DC Office of Planning, working in collaboration with cooperating agencies, will consider all public comments on the Draft Plan and make its final recommendations on the project to the Mayor of the District of Columbia. Subsequently, the Mayor will submit a final Mount Pleasant Street Revitalization Strategy Plan and approval resolution to the District of Columbia City Council for consideration. The Council will consider the final Mount Pleasant Street Revitalization Strategy Plan and approval resolution as it is submitted. The Mayor, through the cooperating agencies will implement the plan.

PLAN SUMMARY:

The Office of Planning (OP) initiated a community planning process with area stakeholders (including residents, ANCs, neighborhood organizations, Council staff, businesses, property owners, institutions and government agencies) and developed a strategic revitalization strategy for the Mt Pleasant Street corridor. The objective of this revitalization plan is to create a more vibrant commercial district by strengthening the commercial corridor’s economic climate, creating a sense of place that can be enjoyed by all residents of the Mt Pleasant neighborhood. Drawing upon multiple conversations and open public meetings with neighborhood residents, community groups and neighborhood stakeholders, in conjunction with OP staff analysis, OP utilized input from these sources to create the foundation for the revitalization strategy based upon three main principles:

1. Improving the economic climate of the corridor;
2. Diversifying the commercial activity by attracting non retail and creative uses; and
3. Enhancing the physical condition of the corridor through sustainable development practices.

Based these principles, OP endeavored to develop a revitalization strategy that has the potential to serve all residents with a safe, pleasant, and walkable retail environment.

The requested text amendments would reinforce the non-conforming use discontinuance provision of 11 DCMR § 2005, establish expiration dates for discontinued and superseded uses permitted by special exception, and provide that all special exception terms begin on the date upon which the order becomes effective.

At its regular public meeting held April 26, 2010, the Zoning Commission setdown this case for a public hearing. The OP report served as the pre-hearing submittal for the case.

The proposed amendments to the Zoning Regulations, Title 11 DCMR, are as follows:

A. Chapter 20, NONCONFORMING USES AND STRUCTURES, Section 2005, DISCONTINUANCE, is amended as follows:

1. By amending § 2005.1 by striking the phrase “a period of more than three (3) years” and inserting the phrase “any period of more than three (3) years” in its place, so the provision will read as follows:

2005.1 Discontinuance for any reason of a nonconforming use of a structure or of land, except where governmental action impedes access to the premises, for any period of more than three (3) years, shall be construed as prima facie evidence of no intention to resume active operation as a nonconforming use. Any subsequent use shall conform to the regulations of the district in which the use is located.

2. By adding a new § 2005.2 to read as follows:

2005.2 This presumption may only be rebutted by objective proof of a continuing use or of affirmative steps taken to resume the use during the period of time identified by the Zoning Administrator when revoking an existing certificate of occupancy or denying an application for a replacement certificate of occupancy.

B. Chapter 31, BOARD OF ZONING ADJUSTMENT RULES OF PRACTICE AND PROCEDURE, is amended as follows:

3131.1 When the Board limits its approval of a special exception to a term of years, the length of that term begins on the date upon which the order became final.

3132 EXPIRATION OF SPECIAL EXCEPTION USES

3132.1 If a special exception use is established, the use will only expire if:

- (a) An expiration date is specified in the order;
- (b) The special exception use is discontinued for any reason for any period of three (3) or more years; except where governmental action impedes access to the premises; or
- (c) A certificate of occupancy for a different use is issued.

3132.2 If a special exception use expires, any subsequent use shall conform to the regulations of the district in which the use is located.

On December 14, 2009, the Office of Zoning received an application from the Lowell School (the "Applicant" or "School"). The Applicant is requesting approval to modify a planned unit development ("PUD"). The Office of Planning provided its report on April 2, 2010, and the case was set down for hearing on April 12, 2010. The Applicant provided its prehearing statement on April 23, 2010.

The property that is the subject of this application consists of approximately 361,378 square feet of land area and is located at 1640 Kalmia Road, NW (Square 2745F, Lots 815, 817). The subject property is zoned R-1-A.

The Applicant proposes to expand the School to include 7th and 8th grades, increase the number of faculty and staff to 100 and to renovate and further develop the campus. It does not propose to increase the cap on student enrollment. In addition to expanding its services and increasing the faculty and staff cap, the School is proposing two phases of physical improvements to its campus. The first phase includes the renovation of and addition to the Parkside building along 17th Street to accommodate the 7th and 8th grade classrooms (in addition to the existing 6th grade classrooms). The addition will include computer labs, art studios, a theater, library and gathering places.

The second phase will include the razing of an existing building, Fraser Hall, and replacing it with a below-grade garage with recreational space on top of it, at grade. At the same time, the School will expand its gymnasium. In all, the development results in a net reduction of approximately 7,305 square feet of development and a net gain of 46 parking spaces. The resulting floor area ratio, once the proposed work is completed, will be .34 and the lot occupancy will be 15%.

How to participate as a witness.
