

The legislation was deemed approved without the signature of the Mayor on February 3, 2010, pursuant to Section 404(e) of the Charter, the bill became Act 18-306 and was published in the February 19, 2010 edition of the D.C. Register (Vol. 57, page 1485). Act 18-306 was transmitted to Congress on February 23, 2010 for a 30-day review, in accordance with Section 602(c)(1) of the Home Rule Act.


